\* Applicant will be required : (i) to provide proof of ownership along with application and (ii) NOC for opening of Bank/ATM from competent Authority at their own cost at the time of finalization. **Technical Bid submitted without NOC for opening of Bank/ATM from Competent Authority will be summarily rejected.**

- The offerer must have a clear title to the property.
- Premises should preferably be located on **ground floor** and in case on upper floors, premises should have lift facility.
- The premises must be suitable from the security point of view and have all basic amenities such as adequate sanitary arrangements, water and electricity, natural light and ventilation.
