Intending bidders are advised to conduct search in Revenue / SRO records to satisfy title, identity, extent, dimensions, survey number, door number, boundaries or encumbrances in regard to the property proposed to be sold. 2) Intending bidders shall hold a valid Digital Signature Certificate (Class II / Class III).
