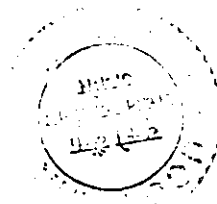

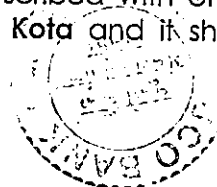

 - (i) To provide **proof of ownership** and **commercialized premises proof** along with application (Annexure-3 Offer Letter).
 - (ii) NOC for opening of Bank and ATM from Competent Authority of their own cost at the time of finalization.
 - (iii) Photographs of Property.
 - (iv) Site plan of the proposed property.
 - (v) Demand Draft in favor of **UCO Bank Zonal office Ajmer** of Earnest Money Deposit (EMD) amount **Rs. 10,000.00** must be submitted along with the application.
