In terms of Section 108 of the Companies Act, 2013 read with Rule 20 of Companies (Management and Administration) Rules, 2014 and relevant provisions of Securities and Exchange Board of India (Listing Obligation and Disclosure Requirements) Regulations, 2015 the Company is pleased to provide its members with the remote e-voting facility to cast their vote electronically on the resolutions mentioned in AGM notice using the electronic voting platform provided by Link Intime India Private Limited (Link Intime). The facility of electronic voting shall also be made available during the meeting on the day of the AGM for those members who have not casted their vote by remote e-voting. The Board has appointed Mr. Sachin Sharma & Dinesh Trivedi Designated Partner of S. Anantha & Ved LLP, (Firm Reg. No. AAH-8229), Practicing Company Secretary, as Scrutinizer for conducting the voting process in a fair and transparent manner. The members may note the following :

a. Members holding shares either in physical form or dematerialized form, as on cut-off date, i.e. Monday, December 07, 2020 may cast their vote electronically.
