4. The bidders or their representative (not more than one) may be present at the time of opening of offer /price bid.
5. The Earnest Money of the successful bidder will be released only after the deposit of the bid amount. Earnest Money Deposit will not be adjusted as bidding amount and will be forfeited, if he fails to honour the bid.
