

DETAILED TERMS & CONDITIONS ARE GIVEN BELOW:

(A)Scope of work:-

- (1) We have 40 Branches/offices under Ayodhya Zone situated in 15 districts of state of Uttar Pradesh, District- wise position of Branches are shown in Annexure- 'D' of this advertisement.
- (2) Work is of doing Electrical audit of Branches for fire safety, energy saving & assessment of compliance of statutory guidelines of State Electricity Department.
- (3) E- auditor should submit their report in prescribed format attached herewith as Annexure-'E', offer their recommendations & suggestions.
- (4) Upon receiving the duly filled E- audit report from Electrical auditor(s), Bank/ Branch will arrange to rectify the deficiencies through at their own sources. After rectification of deficiencies pointed out in E- audit of a Branch, if Bank required to confirm the status of compliance of the same, then Bank can assign the work of Post rectification Electrical audit of any specific Branch to E- auditor. Post deficiencies rectification visits for assessment of level of rectification can be required for selected Branches.

(B) Eligibility Criteria of the bidder person/agency:

- (1) Applicant can be individual / organization.
- (2) Applicant should possess the valid degree in Electrical Engineering Accredited by BEE (Bureau of Energy Efficiency). Photocopy of such certificate should be submitted with the application.
- (3) The person or staff appointed by successful bidder to conduct electrical audit of Branches/Offices must have degree in Electrical Engineering Accredited by BEE (Bureau of Energy Efficiency).
- (4) Bidders have GST & PAN registrations.
- (5) Bidder should have experience in executing the similar work as under at the Public sector Banks/ RBI/ Govt. organizations/ PSU in last 5 years as on 31st January 2024.
- (6) Three similar completed or active contracts in not less than 36 Branches/ locations in last 5 years as on 31st January, 2024. OR
- (7) Two similar completed or active contracts in not less than 45 Branches/ locations in last 5 years as on 31st January, 2024, OR



- (4) Allotment of work: Price bids of eligible bidders would be comparatively evaluated & lowest bid (L-1) would be decided on the basis of price quoted by bidders for Electrical audit per Branch (in column no. 2 of Annexure-'F', Price bid). - (5) Earnest Money Deposit: Bidder has to provide Earnest Money Deposit of Rs. 2000/-(Two thousand) in the form of Demand draft (DD) in favour of UCO Bank ZONAL OFFICE, AYODHYA.

(A) GENERAL TERMS & CONDITIONS:

 The Successful Bidder(s) will be engaged for doing 'Electrical Audit' of Bank's Branches/ Office in State of Ultar Pradesh under Ayodhya Zone of UCO Bank. (District wise list of Branches is shown in Annexure- 'D').

(2) The work is to be started in consultation with General Administration Department/ Security

Department, UCO Bank, Zonal Office Ayodhya.

(3) The Successful Bidder will have to carry out the work without making hindrances to other agencies, whose works are likely to be carried out simultaneously at the same site during working hours.

(4) The Successful Bidder will have to inform the names of their authorized. The Successful Bidder will take all measure on the site of the work to protect the public, our staff as well as their workmen from accidents and shall be bound to bear the expenses related to loss /damage to property, loss of life/injury / medical treatment of any person caused by the act of person doing Electrical audit and defense of every suit, action or other proceedings at law that may be brought by any persons for injury sustained owing to neglect of the above precautions from their end and to pay compensation to any such persons as per law.

(5) Representatives/ Engineer to be deployed at the site for the work.
