<u>Empanelment of vendors for Supply, Installation & Annual Maintenance of CCTV System in the</u> <u>Branches, Currency Chest and Zonal Office under UCO Bank, Raipur Zone.</u>

- **a.** Applications are invited from reputed Agencies/Companies /Firms for empanelment for Installation & Maintenance of CCTV System in the 60 Branches, 07 offsite ATMs, 01 Currency Chest and 1 Office under UCO Bank, Raipur Zone
- **b.** (Wherever necessary) and rates for undertaking Annual maintenance contract (AMC) for existing 60 branches, , 07 offsite ATMs, 01 Currency Chest and 1 Office under Raipur Zone of UCO Bank. Only those applicants who fulfill the Eligibility conditions of this notice will be considered for empanelment.
- **c.** Application should be submitted in the prescribed format mentioned in **Annexure-I**. All the pages should be signed as a token of acceptance.
- **d.** The vendor should meet the eligibility criteria as per details available at **Annexure-II** of this advertisement.
- e. The system should meet with technical specification and details given in Annexure-IV.
- f. Schedule of maintenance in **Annexure-IX**.
- **g.** Empanelment of vendors may be restricted to maximum five vendors in accordance with merit towards fulfillment of Eligibility criteria, technical specification and satisfactory demonstration of "CCTV System".
- h. EMD shall be Rs-5000/-(five thousand only) to be deposited along with tender document PART-1 through Demand draft, Banker's cheque or Pay order in favour of UCO Bank, Zonal Office, Raipur. Tender papers without EMD shall be summarily rejected. EMD is liable to be forfeited in the event of:
 - i. Revocation of the tender or increasing the rates after opening of the tender and before the expiry of the validity of tender.
 - ii. Refusal of the vendor/Contractor to execute the agreement or not complying with the contractual terms & conditions after awarding of contract.
- i. Financial bid should be submitted in Annexure-X.
- j. Vendor has to give buyback offer of old CCTV system in the financial Bid.
- **k.** 10% of the payment will be retained by bank for one year as Defect liability and can be forfeited in the event of non-functioning of the system or non-performance of Vendor.

A. Status of Availability of Security Equipments: -

We have 60 branches (including 56 onsite ATMs), 07 offsite ATMs, 01 Currency Chest and one Zonal Office under the Raipur Zone situated in the state of Chhattisgarh. Each of our branches, Currency Chest & Zonal office have SDVR based analogue / digital CCTV system of 4/8/16 Channel and provided with various types of dome/bullets cameras with IR feature, fixed or varifocal lens. These CCTV systems need to be maintained for their 24x7 functioning which included repair/ replacement of faulty parts, up gradation of obsolete equipments, installation of new equipment on need basis.

B. Scope of Work: -

Maintenance of the available CCTV systems under AMC Non-Comprehensive (repair/replacement of faulty parts). Replacement of old & obsolete DVR/ Cameras with new one on need basis as per our requirement. Re-installation of equipments in case of shifting/ furnishing of branch premises and installation of new system if required in branches, Currency Chests and Zonal Office.

It is highlighted and to be noted by prospective Applicants that they will be required to supply, install and maintain the CCTV System during warranty period at their

own cost and thereafter undertake AMC services as per bank's process. Further they will also be required to undertake AMC services of existing CCTV System already installed and functional at various branches of the bank.

C. Locations To Be Covered: -

The services will be required to be provided in the offices and branches (as required) both existing and opened during the tenancy of this contract, under the jurisdiction of the state of Chhattisgarh.

D. Awarding of rate contract: -

L-1 bidder will be decided on package cost as given in Financial Bid (Annexure VII). Bank may split the work in ratio of 60:40 or in ratio of 60:20:20 amongst L1 and next two bidders who agree to match the rates of L1 as approved and agreed between the Bank and L-1 (hereinafter referred as agreed rates). The offer to bidders to match agreed rates shall be in the ascending order of rates quoted i.e. offer would be given first to L-2 then L-3 then L-4 and so on. The process will continue till the first bidder (in case work is to be split in ration of 60:40) or first two bidders (in case work is to be split in the ratio of 60:20:20) in ascending order of rates quoted accepts to work at the agreed rates. If no other bidder agrees to work at agreed rates then complete work would be awarded to L1.

The decision of the Committee of the bank for allotment of work shall be final and no representation shall be entertained. Concerned Agency will have to enter into an agreement (as per the format decided by the bank) with the Zonal Office.

E. Period of Empanelment: -

Vendor(s) will be empanelled for a period of **03 years** from the date of empanelment for **CCTV System** and it would be reviewed on annual basis on the basis of rendered performance of selected vendor during the rendered service period and participation of empanelled vendors in the coming tender processes. Bank can extend the period of empanelment beyond initial three years on year-to-year basis (1+1) up to 02 years maximum as per decision of the Zonal Office and also Bank can terminate the empanelment of one & all vendors at any point of time by giving a prior notice of 30 days in writing to the successful bidder/vendor without assigning any reason(s) and without any cost(s) or compensation therefore.

F. Inspection of Facilities: -

The applicant should not have any objection to bank inspecting their manufacturing/ R&D/ other infrastructure or any office to verify documentary/ other claims as per application process. Bank may also hold inquiries from past/ existing clients of the applicant.

G. UCO Bank Right to Accept/Reject any/or all Application: -

BANK reserves the right to accept/reject any or all application and to annul the engagement process and accept/reject all applications at any time prior to registration

or any time after registration, without thereby incurring any liability to the affected applicants or any obligation to inform the affected applicants of the grounds for BANK's action.

H. Purchase through GEMS Portal (Government E-Market): -

Bank reserves the right to purchase the system through GeM portal of Govt. of India and provide the same to the vendor for installation and commissioning in the required branch. However, cost of any material/ component provided by the vendor for installation and commissioning of the system would be as per approved rates, including installation charges.

J. Procedure of Empanelment for Annual Maintenance Contract of CCTV System: -

Bidders required to submit their application to the undersigned in three sealed covers along with his complete Address, email and Contact Number for giving information as and when required.

- I. Eligibility Bid in sealed envelope superscribing "PART-I (Eligibility Bid)"
- II. Technical Bid in sealed envelope superscribing "PART-II (Technical Bid)"
- III. Financial Bid in a separate sealed envelope superscribing "PART-III (Financial Bid)".

All the three Parts of Bids will be submitted in one sealed envelope duly super scribed

"Empanelment of Vendor for Annual Maintenance Contract & Supply and Installation, Testing and Commission of CCTV at the Bank Branches under Zonal Office Raipur"

Vendor must sign each page of document submitted failing which the application is liable to be rejected. The proposal received after the time of submission, or without proposal fee and earnest money or conditional applications would be rejected. Further, the Bank reserves the right to accept or reject any or all applications without assigning any reason. Bank reserves right to cancel or withdraw the RFP without assigning any reason. The process of engagement and basic criteria which the Applicants should fulfil for engagement is given in subsequent paragraphs.

- 1) Part I. Eligibility Bid to include profile of the company.
 - a) List of major existing clients, registration number and GST details etc. as mentioned in Appendix-I point-wise. Attach documents wherever required and asked.
 - b) The vendor who is selected for AMC & Installation of CCTV System has to submit Performance Bank guarantee.
- 2) Part II. Technical Bid Technical Bid will be opened after qualification of Part-I i.e. Eligibility Bid.
 - a) To meet the technical specifications: Compliance of technical specifications of CCTV are given in Annexure –VII & XI point wise.
 - b) Demonstration of CCTV is the part of Technical Bid. **Technical Compliance fulfilling** vendors (As per Annexure VII) have to show a demonstration on CCTV, at Zonal Office premises which is the part of technical qualification criteria of vendor for Technical Bid.
- Part-III Financial Bid- Net rates (without any tax calculated) as mentioned in Annexure –X
 (CCTV)

Financial Bids will be opened of those bidders only, who will have qualified successfully Part-I and Part-II.

The Commercial Offer (CO) should contain relevant price information and the rates should be quoted in Indian Rupees only.

The offer from the supplier should be for approved make and model only. The DVR and Cameras should be of the same make. The Bank reserves the right to reject any offer with multiple options.

- 1. Bidder will be empanelled for contract for which the bidder fulfilling the eligibility criteria of Eligibility Bid Annexure- I and Technical Bid as Compliance Sheet and Successful demonstration of CCTV system.
- 2. Bidder need to submit the proofs to validate their experience (copies of work order/contract & performance certificates of the work done to be submitted) in the field of SITC and AMC of CCTV for which the empanelment is sought.
- 3. After assessment of eligibility bids, bank may confirm the authenticity of the work orders/ contract, performance certificate from their client(s) and bank will also confirm the local address of the bidder through own sources, only after the said confirmations the eligibility bid would be adjudged as valid.
- 4. Bidder(s) found eligible based on evaluation of their eligibility criteria confirmation of work/ performance/ local address will be summoned to demonstrate their products for the next stage of assessment for empanelment.
- 5. Only those eligible bidder(s) will be considered for empanelment who's offered products met the requisite specification for the selected security equipment(s).

4) Eligibility criteria for bidders: -

Only those Companies/firms/ agencies that fulfil the eligibility criteria as mentioned in **Annexure-II** of this advertisement will be considered for next stage of assessment for empanelment.

5) Availability of Tender documents & tender fee: -

Tender documents are available on Bank's website www.ucobank.com & at our Zonal Office till last date of submission of bids i.e. 29/09/2023. Bidder required to deposit the non-refundable Tender fee amounting Rs. 250/- (two hundred fifty) in the form of DD in favour of UCO Bank Zonal Office, Raipur and payable at Raipur.

6) Pre-Bid meeting: -

Pre-bid meeting is scheduled to be held at our Zonal Office on 06.10.2023 at 15.00 hrs, interested bidder can submit their queries/ clarifications, suggestion before our purchase committee on schedule date and time. As a resultant of pre-bid meeting any addendum/ corrigendum in bids, its terms & conditions if warranted would be reflected on Bank's website (www.ucobank.com) after a day from pre-bid meeting i.e. from 12/10/2023 & no paper notification would be made for addendum/ corrigendum in bid document. Interested bidders are advised to go through Bank's website after schedule date for any modification in bid document. After pre-bid meeting clarification, suggestion and any type of representation will not be entertained.

7) Opening of Bid(s): -

Sealed bid would be opened at our UCO Bank Zonal Office, as per scheduled opening dates of bid. Bank reserves the right to reject any/all bids without assigning any reason thereto, meanwhile major reasons leading to rejection of bid are specified herein below. Bidders can witness the tender opening process through their authorised representative on scheduled date & time, it is not mandatory for bidder to present at the time of opening of bids. We are not bound to hold the process of opening of tender due to absence of representative of any or all of the bidders at the time of opening of bids. Vendor's

Representative will bring a separate authority letter on company's letterhead with seal and sign to attend opening processes of Bids.

Bids received after scheduled date & time would not be considered for opening & evaluation, sealed bid(s) along with tender fee (if deposited) would be returned to sender's address shown on outer envelope.

8) Evaluation of Bids: -

- 1. Sealed bids received on or before last date would be evaluated based on eligibility criteria as per Annexure-II & checklist Annexure-III.
- 2. Documentary proofs in respect of each eligibility criteria would be evaluated, confirmation of local address, executed work/ performance would be ascertained by Bank. Only after that the bid would be considered for the next stage of empanelment for the field/ security item(s) in which it fulfils the eligibility conditions.
- 3. In the next stage of assessment for empanelment the eligible bidders would be invited for demonstration of their products, in case the offered products found suitable as per criteria fixed by bank, then only the candidature of the bidder is approved for empanelment.
- 4. Empanelment would be restricted to maximum ten bidders for CCTV system SITC & AMC.
- 5. Vendor has to must sign all pages of uploaded Tender RFQ/ RFP and their submitted supporting documents with seal and signature of authorized Representative of their Company/ Firm.

9) Rejection of bids: -

Bank can reject the bids in following cases: -

- 1. Late receipt bids, received in open envelope, received through email.
- 2. Bids not having proper documentary proofs establishing eligibility of bidder.
- 3. Bids not provided with requisite tender form fee.
- 4. Copies of work order/ contract submitted in proof of experience are not supported by performance certificate from client.
- 5. Work/ services of the bidder found unsatisfactory on confirmation from their client.
- 6. Confirmation of local address (in the state of Chhattisgarh) not ascertained.
- 7. Product offered not meets the required specification as evaluated during demonstration.
- 8. Bank can reject any or all of the bids without mentioning any reason.
- 9. Not signed and sealed to all pages of Bids/Tender forms & documents/RFQ/RFP.

10) Performance Security & Earnest money deposit: -

- 1. The successful selected bidder has to deposit a separate Performance Bank Guarantee
- @ 10% of the total cost of contract for **AMC & Installation CCTV System** as per their quoted rate in the bid as security deposit or at applicable rate as prescribed by Govt./ bank's guidelines.
- 2. The successful selected bidder has to deposit a separate Performance Bank Guarantee
- 3. The proposed work order/contract with selected vendor would include suitable clause on uptime of security equipments, penalty for default to regulate the quality of work / service.
- **11) Termination of contract or work: -** The Bank reserve its right to terminate the maintenance and supply contract at any time after giving due **notice of one month** without assigning

any reason. The contractor will not be entitled to claim any compensation against such termination. However, while terminating the contract, if any payment is due to the contractor for maintenance/ work already performed up to satisfaction in terms of the contract, these would be paid to it/ him as per the contract terms.

12) The Bidder's Indemnity and Assurance: -

The Bidder should comply with all legal requirements and obtain such licenses, approvals and consents, if any prescribed/required under any law/ rules/regulations, and keep them valid.

The Bank will not be liable to pay any remuneration or compensation to the Bidder or any of the personnel (including its owner(s), director(s), partner(s), employee(s) and any representative(s) engaged by the Bidder in relation to the service except the total cost of CCTV Security system as per agreement and later AMC charges as per agreement.

The Bidder to indemnify against all losses, liability or obligation arising out of its conduct or that of any of the personnel including its owner(s), director(s), partner(s), employee(s) and representative(s) in connection with the work to be offered to selected vendor.

13. SUB - CONTRACTING: -

The selected service provider/ vender shall not subcontract or permit anyone other than its personnel to perform any of the work, service or other performance required under this project. In case any particular specialized service in the prescribed in the scope of work requires subcontracting it need to be specified in the proposal/ response document with all the details of the work/ services. Please note that no work/services shall be subcontracted without the prior permission from the Bank in writing.

14. SERVICE LEVEL AGREEMENT: -

- (a) The service provider shall be required to enter into a Service Level Agreement with bank, based on terms and conditions mentioned in the tender document within 15 days of issuance of order.
- (b) The successful bidder shall execute a Service Level Agreement (SLA), which contained all the services and terms and conditions of the services to be extended as detailed herein. The successful bidder shall execute the SLA & provide the same along with acceptance of Work Order.
- (c) All the expenses related to execution of the document such as the applicable stamp duty and registration charges if any shall be borne by the successful bidder.

15. Conflict of Interest

The vender shall disclose to Bank in writing, all actual and potential conflicts of interest that exist, arise or may arise (either for the vendor or the Bidder's team) in the course of performing the service(s) as soon as practical after it becomes aware of that conflict.

16. Authorise Representative

A power of Attorney / Authorisation Letter from the bidders Authorised officials / Body must be enclosed with the bid certifying that the person(s) who signed the bid is an authorized person on behalf of the bidder.

17. Publicity

Any publicity by bidder in which name of UCO Bank appears, is to be used only after receiving explicit written permission from UCO Bank.

18. Integrity Pact.

Each and Every bidder has to execute pre contract integrity pact as per Bank's format as per (Annexure-E) on non-judicial stamp paper of appropriate value. Scanned copy of pre contract integrity pact must be uploaded in our e-tender website.

UCO Bank has adopted practice of Integrity Pact (IP) as per CVC guidelines. The Integrity Pact essentially envisages an agreement between the prospective vendors/ bidders / sellers, who commit themselves to Integrity Pact (IP) with the Bank, would be considered competent to participate in the bidding process. In other words, entering into this pact would be the preliminary qualification. In case of bids for the purchase of Goods, Services, and Consultancy etc. not accompanied with signed IP by the bidders along with the technical bid, the offers shall be summarily rejected. The essential ingredients of the Pact include:

- Promise on the part of the principal not to seek or accept any benefit, which is not legally available.
- Principal to treat all bidders with equity and reason.
- Promise on the part of bidders not to offer any benefit to the employees of the Principal not available legally.
- Bidders not to enter into any undisclosed agreement or understanding with other bidders with respect to prices, specifications, certifications, subsidiary contract etc.
- Bidders not to pass any information provided by the Principal as part of business relationship to others and not to commit any offence under PC/IPC Act.
- Foreign bidders to disclose the name and address of agents and representatives in India and Indian Bidders to disclose their foreign principals or associates.
- Bidders to disclose any transgressions with any other company that may impinge on the anti-corruption principle.

Integrity Pact, in respect of a particular contract, shall be operative from the date IP is signed by both the parties till the final completion of the contract. Any violation of the same would entail disqualification of the bidders and exclusion from future business dealings. IP shall cover all phases of contract i.e. from the stage of Notice Inviting Tenders (NIT)/Request for Proposals (RFP) till the conclusion of the contract i.e. final payment or the duration of warrantee/guarantee. Format of IP is attached as Annexure-..... for strict compliance.

19. SETTLEMENT OF DISPUTES

In case of dispute or difference of any kind whatsoever arise between the Bank and the Vendor/ Contractor in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such disputes or differences by mutual consultation.

If after 30 days the parties fail to resolve their disputes or differences by such mutual consultation, then either the bank or the vendor may give notice to the other party of its intention to commence arbitration, as hereinafter provided, as to the matter of dispute. No arbitration in respect of this matter may be commenced unless such notice is given.

Any dispute or difference in respect of which a notice of intention to commence arbitration has been given in accordance with this clause shall be settled in accordance with the Arbitration and Conciliation Act, 1996.

Arbitration proceedings shall be held at Bank's office i.e. Zonal Office, Raipur that placed the order and the language of the arbitration proceedings and that of all documents and communications between the parties shall be in English.

The process of arbitration shall be conducted by a sole Arbitrator appointed by the Bank.

20. Force Majeure

Force Majeure is herein defined as any cause, which is beyond the control of the selected bidder or UCO BANK as the case may be which they could not foresee or with a reasonable amount of diligence could not have been foreseen and which substantially affect the performance of the contract, such as:

- Natural phenomenon, including but not limited to floods, droughts, earthquakes and epidemics
- Acts of any government, including but not limited to war, declared or undeclared priorities, quarantines and embargos
- Terrorist attack, public unrest in work area

Provided either party shall within 10 days from occurrence of such a cause, notify the other in writing of such causes. The bidder or UCO BANK shall not be liable for delay in performing his/her obligations resulting from any force majeure cause as referred to and/or defined above. Any delay beyond 30 days shall lead to termination of contract by parties and all obligations expressed quantitatively shall be calculated as on date of termination. Notwithstanding the above, provisions relating to indemnity, confidentiality, survive termination of the contract shall remain same.

21. Liquidated Damage

Liquidated damages for fail to supply wholly or partly, as per term of our order, non-performance, non-supply in time or supplying the materials which do not confirm the specification/quality prescribed or which is found defective will entail @ 1% (One percent) of the order value per week will be charged for every week's delay from 9th week in commissioning to a maximum of 10% of the order value.

UCO BANK reserves its right to recover these amounts by any mode as it deems fit and proper such as adjusting from any payments to be made by UCO BANK to the bidder, etc. without prejudice to its other rights and contentions available under the Law (s) for the time being in force. Liquidated damages will be calculated on per week basis.

22. No Legal Relationship

This RFP is not an offer by the bank, but an invitation for the vendor responses. No contractual obligation on behalf of the Bank whatsoever shall arise from the RFP process unless and until a formal contract is signed and executed by duly authorized officials of the Bank and the Vendors.

Confidentiality

The bidder must undertake that they shall hold in trust any information received by them, under the contract/ agreement, and the strictest of confidence shall be maintained in respect of such information. The bidder has also to agree:

- To maintain and use the information only for the purpose of the contract/ agreement and only as permitted by Bank.
- To only make copies as specifically authorized by the prior written consent of bank and with the same confidential or proprietary notices as may be printed or displayed on the original.
- To restrict access and disclosure of information to such of their employees, agents, strictly on a "need to know" basis to maintain confidentiality of the information disclosed to them in accordance with this clause and
- To treat all information as confidential information.

Other Terms & conditions: -

1. Modification and withdrawal of bids:

Bid withdrawal/ modification shall not be allowed after last date and time of bid submission. Withdrawal of bid after last date and time may result in forfeiture of earnest amount. Bid modification after last date and time will not be allowed.

For any queries, bidder may contact us on working days between 10 A.M. to 5 P.M.

- 3. <u>Clerical errors to be rectified:</u> Neither of party/ vendor shall take any advantage of any clerical error or mistake which may creep in or occur in the specifications, schedule of rates, plans, instructions of tenders or any other papers supplied to or by the vendor in connection with the work, but such clerical errors or mistake shall be brought to the notice by the one to the other without any loss of time and same shall be rectified during pre-bid meeting.
- 4. Tender is valid up to four (04) months from the date of publication.
- 5. Any dispute arising in this matter will be settled in the jurisdiction of, Chhattisgarh.
- 6. All pages the tender form & documents to be properly signed and sealed by an authorized person/ representative on behalf of the company as a token of acceptance of all terms & conditions mentioned in the tender form & documents.
- 7. In case our office is declared closed on the last date of receipt or pre-decided date of opening of tender due to holiday/ Bandh call /Lockdown etc., the respective date shall be treated as deferred/re-scheduled to the next working day.
- 8. Financial Bids will be opened in the presence of vendors' representatives. If the representative will not be present at the time of opening of bids, L-1 will be selected ex-parte.
- 9. It may be noted that the requirement given in this RFP is indicative only.
- 10. Tender /Offers sent through Fax and E-mail will not be accepted.
- 11. Bank reserves the right to accept / reject in part or in full any or all offers without assigning any reason whatsoever and without any cost or compensation therefore. Any decision of UCO Bank in this regard shall be final, conclusive and binding on the bidders.
- 12. The empanelment period for the empanelled vendors will be for a period of 03 (Three) years. However, if our Head Office or any higher office of UCO Bank conducts Pan India Rate contract, Zonal office, will have the right to cancel this Rate contract. In such case notice of one month will be served to the firm for termination of Rate contract and no other claims will be entertained.

- 13. Branch count, Branches with ATM (either at on site or off site) will be under AMC of CCTV of that particular branch and no separate visit will be counted for the ATM visit, whether it is located near or far from Branch location.
- 14. Please read carefully all the points of Bids/ Tender forms & documents/RFQ/RFP and duly sign on each page with company seal (encrypted Designation with name of the company) as token of acceptance and deposit it mandatorily with the tender documents.

- 1) Vendor should have local representative Office under Banks Raipur Zone area preferably at Raipur for installation services. The vendor is to give complete address. Telephone number along with technical personnel available with them for this work.
- 2) Vendor has to submit a certificate from the manufacturers along with technical specifications that they are the authorized agents for the sale and service of their product and manufacturer undertakes to support the after sales service of the product.
- 3) Vendor will have to essentially mention the name of the company whose product is to be supplied and the country of origin of the product along with technical specifications. They will also to have certificate in respect of country of origin.
- 4) All products will stand for onsite all comprehensive warranty against all manufacturing defects. During the warranty period the vendor shall have to provide quarterly preventive service calls and shall have to attend to all breakdown calls within 24 hours.
- 5) AMC charges will be payable after expiry of warranty period as per terms & conditions mentioned herein.
- 6) Vendor will have to submit a certificate from the manufacturer that the spare parts for the supplied product will be available for after sales service.
- 7) The vendor may be asked to give Bank guarantee of Rs-10% of the cost of work (performance guarantee). However this amount may vary depending upon the total cost of the work.
- 8) The vendor will have to submit documentary evidences confirming Registration with sales tax, service Tax and ESI & EPF.
- 9) Earnest money shall be retained till the completion of the job and will be adjusted in the final payment.
- 10) The vendor has to submit his acceptance of the work order within 10 days from the date of receipt of information from the Bank. In case the vendor fails to undertake the work, the earnest money deposited by them will be forfeited and acceptance of their tender will be withdrawn.
- 11) The rates quoted by the vendor should be inclusive of all charges for scaffolding, lift, any other tools and plants, railway/road freight, labour conditions and fluctuations in the rates, excise duty, sales tax, octroi and any other taxes or expenditure for carrying out the employment
- 12) The liquidity damages as mentioned above may not be enforced if the vendor applies for extension of time mentioning the reasons for such extension. Bank may grant such extension in case it is found that the vendor is not at fault for extending the work beyond the stipulated date of completion
- 13) The vendor will be bound to carry out items of work necessary for completion of the job even though the same is not included in the Bill of quantity.
