The following terms & conditions should be complied with, while submitting the offer for the proposed premises:

Sl No.	Particulars
1	Applicant will be required i. to provide proof of ownership along with application ii. to provide NOC for opening of bank/ATM from competent authority at their own cost at the time of finalization.
2	The offerer must have a clear title to the property.
3	Premises should be located on ground floor/First Floor (road level).
4	The premises offered for Branch must be within 500 meters of the existing Branch premises and at the ground floor (road level) or first floor (where lift / elevator is available) within the main market area and easily accessible from the main road.
5	The premises must be suitable from the security point of view and have all basic amenities such as electricity, natural light and ventilation.
6	The structure of the offered premises should be strong enough to bear the weight of Vault, Locker cabinets etc.
7	The offerer will have to execute Bank's standard lease deed and bear the cost of execution and registration of Lease Deed.
8	The offerer should bear all the taxes, non-conforming/misuse charges, cesses etc. if imposed, related to the premises.




9	The offerer is to provide space for Generator Set, Toilets and Parking space free of cost.
10	The offerer is to provide three-phase electricity connection with minimum power load of 10 KVA for the purpose.
11	Carpet area will not include common areas shared with other co-tenants (if any), areas covered by walls, pillars, toilets, staircase, uncovered verandah, corridor and passage.

The cover containing technical detail should be marked envelope no. 1 and super-scribed with Technical Bid and the cover containing financial details should be marked as envelope no. 2 and super-scribed with Financial Bid. 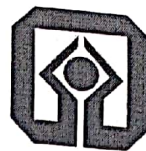

- While filing the quotation forms, please ensure to follow below mentioned instructions:

Sl No.	Particulars
1	Copy of document of ownership is to be submitted along with Technical Bid (Part I).
2	Copy of "NOC" for opening of Branch / ATM from competent authority is to be submitted.
3	All the information asked for is to be filled up in the enclosed format itself.
4	Do not quote rent / sale price anywhere in Technical Bid (Part I) of the form.
5	In case you desire to stipulate any terms and conditions, the same should be mentioned in Technical Bid (Part I) of the form.
6	Each part, Technical bid (Part I) and Financial Bid (Part II), should be kept in separate envelopes and the envelope containing Technical Bid (Part I) details should be marked as 'Envelope No.1 – Technical Bid' and the cover containing Financial Bid (Part II) details should be marked as "Envelope No.2 –Financial Bid".
