1	Applicant will be required i. to provide proof of ownership along with application ii. to provide NOC for opening of bank/ATM from competent authority at their own cost at the time of finalization.
2	The offerer must have a clear title to the property.
3	Premises should be located on ground floor/First Floor (road level).
4	The premises offered for Branch must be within 500 meters of the existing Branch premises and at the ground floor (road level) or first floor (where lift / elevator is available) within the main market area and easily accessible from the main road.
5	The premises must be suitable from the security point of view and have all basic amenities such as electricity, natural light and ventilation.
6	The structure of the offered premises should be strong enough to bear the weight of Vault, Locker cabinets etc.




7	The offerer will have to execute Bank's standard lease deed and bear the cost of execution and registration of Lease Deed.
8	The offerer should bear all the taxes, non-conforming/misuse charges, cesses etc. if imposed, related to the premises.
9	The offerer is to provide space for Generator Set, Toilets and Parking space free of cost.
10	The offerer is to provide three-phase electricity connection with minimum power load of 10 KVA for the purpose.
11	Carpet area will not include common areas shared with other co-tenants (if any), areas covered by walls, pillars, toilets, staircase, uncovered verandah, corridor and passage.
