The following amendments have been made in the e-Tender clauses as per discussions held in Pre-bid meeting & as per approval of the competent authority.

SI No	Queries raised by Vendors	Bank's Reply
1	Armed Guard- Preferably Ex-Servicemen or Civilian	Civilian PSA armed guards with valid Gun license will be allowed , no preference shall be given to ex-serviceman. However, the service provider may engage ex-serviceman also.
2.	Fidelity Insurance	PSA agency will obtain this
3.	Bidder should have valid PSARA License for WB	Without valid PSARA License no bidder will be allowed. However, vendors applied for renewal with valid documents are allowed, but they should obtain it by 31.03.2024.
4.	Period of Service	Tenure will be Three years from the date of issuance of work order.
5.	CCTV System	As per guidelines issued by MHA in PSARA Rules 2018-First Schedule
6.	Termination	Selected Vendor may exit from the service after one year subject to 60 days Notice on reasonable ground. Bank may impose penalty to the vendor amounting to hiring service charges for two months at the time of exit.
7.	Non-Assignment Clause	No vendor will be allowed to out source or engage third party for manpower or cash vans
8.	Number of total crew per vehicle	Total crew will be Five per vehicle, including one driver, one loader, one custodian, two armed guards.
9.	Waiver of tender fees	As per Govt. of India- MSME guidelines, tender fees and EMD will be waived if the PSA is registered under MSME for Security services.
10.	Toll fees	Toll fees for CRT purpose will be reimbursed on actual basis by the concerned branch of UCO Bank
11.	Scope of work	The L-1 service provider will start
