
Procedure for submission and opening of Tenders:

- 1. Part I of tenders should be submitted in separate sealed covers, super scribing "PART-I (Technical Bid)" and location(s) of installation. Part-I of tenders should contain the following"
 - (i) Make, model and capacity of Inverter.

(ii) Warranty period.

- (iii) A letter from the bidder towards acceptance of scope of services and terms & conditions for supplying and commissioning of inverter in Branch/Office, as mentioned in the Notice Inviting Tender.
- (iv) Earnest money of Rs. 21000.00 (Rs. Twenty One Thousand Only), in the form of DD/Pay Order drawn in favour of "UCO Bank" and payable at **Bhagalpur**.

There should not be any indication of price/ rate/ charges in Part –I of the tender. Conditional tenders will be not accepted.

- 2. Part –II of tenders should be submitted in separate sealed cover, super scribing "PART-II (Price Bid)" of installation. Part-II of tenders should contain the rates as per the following schedule.
- 3. Separate sealed envelopes containing Part-I and Part-II of tenders should be put in another sealed cover, super scribing "OFFER FOR SUPPLYING AND COMMISSIONING OF INVERTER and BATTERIES" and submitted to UCO Bank, Zonal Office, S K Tarafdar Road, Adampur, Bhagalpur-812001 by 5:00 P.M. on 14.03.2024.
- 4. Part-I of tenders will be opened at 11:00 A.M. on 18.03.2024 in presence of representatives of participating tenderers who intend to remain present in the tender opening process. Part-II of all un-conditional tenders, which comply with the requirements/ conditions of Part-I, will be opened thereafter on the same day in presence of attending representatives of participating tenderers.

Eligibility Criteria:

- i) The bidder must be an OEM or Authorised Supplier of OEM and should be a registered company in India under Companies Act 1956 or amended Companies Act 2013.
- ii) The bidder should be a profit-making company / firm (Profit before Tax) in last three financial years.
- iii) The bidder must be registered under GST.
- iv) The bidder should have PAN.
- v) The bidder should have experience in executing the similar work as under at Public Sector Banks / RBI/ Govt Organization/ PSU:
 - a) Three similar completed works costing not less than the amount equal to 40% of the estimated cost within five years ending last day of the month previous to the one in which application are invited in execution of similar works. Or
 - b) Two similar completed works costing not less than the amount equal to 50% of the estimated cost within five years ending last day of the month previous to the one in which applications are invited in execution of similar works. Or
 - c) One similar completed work costing not less than the amount equal to 80 % of the estimated cost within five years ending last day of the month previous to the one in which application are invited in execution of similar works.
- vi) The bidder should have well equipped registered service center in Bhagalpur district (Location of Branch / Office).

Terms and conditions:

- i) The rate quoted in the tender must be inclusive of all taxes, duties, delivery & installation charges at site.
- ii) Installation: Within 02 weeks from the date of issue of work order.

- iii) Warranty: Minimum two years comprehensive onsite warranty for inverter and 4 years (Replacement warranty) for the Batteries.
- iv) Payment Terms: After satisfactory supply, installation, testing & commissioning of the item subject to statutory deductions as per rule 10% will be deducted before release of payment and will be kept as Security Deposit and will be released after defect liability period on one year from the date of installation without any interest if there is no damage claim.
- v) Vendor should enclose the technical specification /catalogue /brochure of their specified model with the quotation.
- vi) Vendor other than manufacturer of inverter & Battery has to submit their dealership /distributorship certificate from the manufacturer of is preferable.
- vii) Vendor/Manufacturer has to submit all supporting documents to fulfill the eligibility criteria.
- viii) The Bank reserves the right, not to execute the full quantity of items, as mentioned in schedule of quantities.

COMPRESHENSIVE ANNUAL MAINTENANCE CONTRACT CHARGES:


Bank may go for Comprehensive Annual Maintenance Contract (including all spare parts) @ 5% of bill value (excluding GST) of machine in each year for a period of three years after expiry of warranty period of inverter. Scope of work of Comprehensive Annual Maintenance Contract (CAMC) will be governed as per stipulated terms and conditions of Bank.

CRITERIA FOR EVALUATION OF TERNDERS AND DETERMINING THE COMPARATIVE POSITION:

The Eligibility would be evaluated first for the participating bidders. The bidders, who would qualify all Eligibility Criteria as mentioned above, will be shortlisted for the technical bid evaluation. A detailed technical evaluation of Inverter & batteries would be undertaken for eligible bidders and only the technically qualified bidders would be shortlisted for commercial opening. The bidder with the lowest commercial quote will be declared as L1.


