1) Estimated cost - Rs.9,80,100/- plus GST

1.Scope of work:

Supply Installation Testing Commissioning of 6 Nos Split Air Conditioning Units and 7 Cassette Air Conditioning Units at Banks Building at 2, India Exchange Place at Kolkata at detailed herein under:

Site for Installation: Bank's building at India Exchange Place, Kolkata – 700001.

2. WARRANTY : 1-year comprehensive warranty for the machine & 4- years additional warranty for the compressor or as per company rule whichever is higher.

3. Completion time of work: 4 (Four) weeks from seventh day of the date of award of work or handing over of site whichever is later.

4.PAYMENT TERMS: payment against supply of A.C units will be released after delivery of all materials at site considering delivery of materials at site upon production of proper documentary evidence. Payment for installation charges will be released against your bill after satisfactory installation, testing & commissioning of the full quantity based on actual measurement, subject to compliance of terms of contract by the contractor and statutory deductions as per Rule.

5.ORDER CANCELLATION.:The Bank reserves its right to cancel the entire / unexecuted part of Purchase Order at any time by assigning appropriate reasons in the event of one or more of the following conditions treating it as default / non performance of the contract:

- **a.** Fails to accept the purchase order within the specified time .
- **b.** Delay in execution of work beyond the specified period.
- c. Serious discrepancies noted in the items delivered.
- ${\bf d}.$ Breaches in the terms and conditions of the Order

6. Additional Terms & Condition on Taxes is as follows:

- You have to confirm that the GST amount charged in invoice is declared in its returns and payment of taxes is also made.
- You have to comply with all applicable GST laws, including GST acts, rules, regulations, procedures, circulars & instructions there under applicable in India from time to time and to ensure that such compliance is done within the time prescribed under such laws. You have should ensure accurate transaction details, as required
