

The interested bidder(s) will submit their highest bid along with copy of self certified KYC documents (Identity proof and latest address proof i.e. Aadhaar Card, PAN card, Voter Id) ,Earnest Money Deposit DD of Rs. 10000/- in the name of UCO Bank, Zonal Office, New Delhi.


<u>Bidder should mention subject on sealed envelope like 'Offer for purchase of Old Vehicle of</u> <u>UCO Bank' along with details of the bidder like name, address, contact no, email ID etc.</u>

Terms and conditions:

- Bid(s) has/ have to submit for purchase of Bank's old vehicles on the basis of "As is where is basis and as is what is" and on "No complaint basis" and no guarantee or certificate of its worthiness or quality will be given by the bank.
- 2. Bid(s) will be accepted only in prescribed format attached as Annexure-I.
- 3. The bidders or their representative (not more than one) may be present at the time of opening of offer /price bid.
- 4. The Earnest Money of the successful bidder will be released only after the deposit of the bid amount and submission of proof of transfer of ownership of the vehicle in the name of purchaser. Earnest Money Deposit will not be adjusted as bidding amount and will be forfeited, if he fails to honour the bid.
- 5. The successful bidder cannot withdraw bid, failing to which Earnest Money Deposit will be forfeited.
- 6. Bids received without demand draft towards Earnest Money & application fee will not be considered and shall be rejected.
- 7. Bids received below the reserved price of the respective vehicle shall be rejected.
- 8. The delivery of the sold vehicle will be given only after the receipt of full bid amount (sale price of vehicle) & verification of KYC documents and physical verification address of KYC by Bank of successful bidder.
- The successful bidder will deposit the total bid amount within 05 (Five) working day by the means of Demand Draft /NEFT in favour of "UCO Bank Zonal Office New Delhi" Payable at New Delhi.
- 10. The sold vehicle shall have to be taken by the successful bidder immediately at his own expenses/ cartage within 10 working days of bank after deposit of total bidding amounts.
- 11. In case of failure to deposit final bidding amount within given time, the vehicles may be sold to H-2, H-3, H-4....etc. bidder(s) on quoted price of H-1 Bidder if agreed by them.
- 12. Legal, statutory compliances whichever is/are required like RTO certification, tax, pollution under control certification, Insurance, Renewal of Fitness certificate, other formalities required for the running of vehicle will be carried out and borne by successful bidder at his/ her/ their own expenses. Bidder can check the documents of vehicle at the time of inspection of vehicle.
- 13. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. - 14. If, the successful bidder purchases vehicle(s) for scrapping the vehicle(s) then bidder will submit an affidavit of declaration to submit the cut part of the chassis number to concerned RTO immediately within 15 days of cartage of vehicle. We will return Earnest Money Deposit to the purchaser after receiving a copy of issued NOC/ necessary letter on behalf of depositing cut part of Chassis no. by concerned RTO against submission of cut part of the chassis number of our sold vehicle. In case of non-submission of Chassis no. to RTO Bank shall initiate legal action against Successful bidder/ Purchaser.
- 15. After completion of all document related formalities of changing the name in Registration Certificate, Insurance and Pollution Certificate, a self attested copy of these each document by the new owner must be submitted to our office and only after that EMD will be released. In case of scrapping of vehicle(s) then after submission of cut part of Chassis no. of concerned vehicle to our office then EMD will be released.
- 16. Rate for purchase of old vehicles to be quoted in "Annexure-I". (If a bidder is interested to bid for all the 4 vehicle, he/ she has to submit 4 offer separately)
- 17. EMD of unsuccessful bidder shall be returned.
- 18. The delivery of the sold vehicle will be arranged only after the successful bidder deposit full cost of purchase of vehicle & submits documentary evidence in support of residential status (Ration Card/Voter ID/ Aadhar Card/ Passport) in case of individual and Registration Certificate in case of firms or company etc.
- 19. A signed and sealed copy of all tender papers has to attach/submit with the bid by bidder/ purchaser as a token of acceptance of all terms & conditions of the tender will be submitted. If not submitted the Tender will be liable to reject.


