- Applicant will be required: (i) to provide proof of ownership along with application and (ii) NOC for opening of bank/ATM from Competent Authority at their own cost at the time of finalization.

- Premises should preferably be on ground floor having good frontage, visibility, adequate power supply and parking facility or on first floor if the same is in malls, Shopping Centers where infrastructure facilities like lifts, escalators and parking etc., are available.
