The following terms & conditions should be complied with, while submitting the offer for the proposed premises:

- Applicant will be required: (i) to provide proof of ownership along with application and (ii) NOC for opening of bank/ATM from Competent Authority at their own cost at the time of finalization.
- The offerer must have a clear title to the property.
- Premises should preferably beon ground floor having good frontage, visibility, adequate power supply and parking facility or on first floor if the same is in malls, Shopping Centers where infrastructure facilities like lifts, escalators and parking etc., are available.
- The premises must be suitable from the security point of view and have all basic amenities such as adequate sanitary arrangements, water and electricity, natural light, ventilation and parking
- The premises structure should be strong enough to bear the weight of Strong Room, Strong Room Doors, Safe& Lockers Cabinet. Collapsible gate and Construction for Strong Room as per Bank's specification should be done by the Landlord.
- The offerer will have to execute Bank's standard lease deed and bear 50% the cost of execution and registration of Lease Deed.
