Applications are invited from reputed Agencies/Companies/Firms for empanelment for Installation & Maintenance (AMC) of Security equipment **CCTV**, **Digital Fire Cum Burglary Alarm System & Fire Extinguisher** in 88 Branches and 1 Office under UCO Bank, Kolkata Zone.

- (A) Status of availability of Security equipments: -
  - We have 88 (Eighty Eight) Branches and 01 (One) Office under Kolkata Zone. Each of our Branches and Offices has been provided with:
  - **Digital Fire Cum Burglary Alarm System:** Our Branches and Offices have either Fire cum Burglar integrated Alarm System or separate fire alarm and burglar Alarm System. Alarm Systems are provided with various types of sensors like Panic Switch, Vibration, Tilt, Magnetic contact, Smoke, Heat, Multi, PIR sensor, Hooter & Motorized siren, Autodialed (PSTN/ GSM).
  - CCTV System:-Our Branches and Zonal Office have SDVR based analogue/digital CCTV system of 4/8/16/32 Channels, standalone IP camera and additional 4 channels CCTV system in 61 locker branches. CCTV Systems are provided with various types of Dome/Bullets cameras with IR feature, fixed or varifocal lens.
    - These security equipments need to be maintained for their 24x7 functioning which includes Repair/Replacement of faulty parts, Upgradation of obsolete equipments, Installation of new equipments on need basis.
  - **Fire Extinguisher:** Our Branches and Offices have Manually Operated Fire Extinguishers consisting of Dry Chemicals, Water & CO<sub>2</sub> containers.
- (B) Scope of work: -

The selected vendor will supply, install and maintain the **CCTV System, Digital Fire cum Burglar Alarm System and Fire Extinguisher** with Technical Specifications provided in the RFP documents in branches under kolkata Zonal Office.

The Vendor should indicate in his RFP, the following particulars in addition to those called for in the System requirement and Technical Specifications:

- i) Complete description of the working of the System/sub systems.
- ii) Requirement of equipment-wise electric power consumption.
- iii) Required environmental conditions for safe operation/storage.

The scope of work shall include shop testing, supply including testing and handing over of the equipment supplied as per Technical Specifications at the Bank's office buildings and at the locations specified by the Bank.

The Vendor shall carefully check the specifications and shall satisfy himself that the equipment offered is suitable as per the enclosed Technical Specifications and shall take full responsibility for the efficient operation and guarantee of the specified output of the equipment offered. The scope of work for Supply, Installation and Maintenance (AMC) of security equipments is

as follows:

- For Digital Fire Cum Burglary Alarm System: Maintenance of the available Fire alarm & Fire cum Burglary Alarm Systems under (AMC), Repair/Replacement of faulty parts. Replacement of old and obsolete Alarm panel/System with new one on need basis. Re-installation of equipments in case of shifting/ furnishing of Branch premises and installation of new System in new opened Branch.
- For CCTV System: Maintenance of the available CCTV Systems in all Branches plus 4 Channel CCTV System in 61 locker Branches under (AMC), repair/replacement of faulty parts. Replacement of old and obsolete DVR/Cameras with new one on need basis. Re-installation of equipments in case of shifting/furnishing of branch premises and installation of new system in new opened branch.
- For Fire Extinguisher: Maintenance and Refilling and servicing of the existing Manually Operated Fire Extinguishers consisting of Dry Chemicals, Water & CO<sub>2</sub> containers. Installation of New Equipments and Containers and necessary upgradation or replacement of existing equipments and containers.

#### (C) Period of Empanelment:-

Vendor(s) will be empanelled for a period of **03 (three) years** from the date of empanelment and it would be reviewed on annual basis on the basis of performance of selected vendor and participation of empanelled vendors in the coming tender processes. Bank can extend the period of empanelment beyond initial three year on year-to-year basis. Bank can terminate the empanelment on one and all vendor at any point of time.

#### (D) Procedure of Empanelment: -

- 1. One bidder can apply for empanelment for one or more Security item(s), bidder have to spell out the name of item, CCTV System or Digital Alarm System for which the empanelment is sought.
- 2. One bidder can be empanelled for one or more item(s) for which the bidder fulfils the eligibility criteria.
- 3. Bidder(s) need to submit the proofs to validate their **experience** (copies of work order/contract & performance certificates of the work done) in the respective field i.e. CCTV/Alarm system/Fire extinguishers for which the empanelment is sought.
- 4. After assessment of eligibility bids, bank may confirm the authenticity of the work orders/contract, performance certificate from their client(s) and bank will also confirm the local address of bidder(s) through its own sources. Only after the said confirmations the eligibility bid would be adjudged as valid.
- 5. Bidder(s) found eligible on the basis of evaluation of their eligibility criteria, confirmation of work/performance/local address, will be summoned to **demonstrate** their products for the next stage of assessment for empanelment.
- 6. Only those eligible bidder(s) will be considered for empanelment who's offered products meet the requisite specification for the selected security equipment(s).
- 7. When the Price Quotation will be received from the empanelled vendors/company, at that time preference can be given to the item price offered by the OEM (original equipment manufacture).









8. The Zonal Office will collect a price list of all the Security Gadgets/Items from the OEM companies. If the selected Empanelled vendor/Agency gives a price quotation more than OEM price, then the price quotation of that vendor will be rejected.

#### (E) Eligibility criteria for bidders:-

Only those Companies/firms/agencies that fulfill the eligibility criteria as mentioned in- 'Annexure-I' of this advertisement will be considered for next stage of assessment for empanelment.

#### (F) Availability of Tender documents & tender fee:-

Tender documents are available on Bank's website <a href="www.ucobank.com">www.ucobank.com</a> as well as at our Zonal Office till last date of submission of bids i.e. 28/08/2024. Bidder(s) are required to deposit the non-refundable Tender fee amounting Rs. 1000/-(Rupees One Thousand only) either in the form of DD in favor of Zonal Office, Kolkata, payable at Kolkata, and requisite DD should be submitted with bid. There is no exemption for this and it is mandatory.

#### (G) Pre-Bid meeting:-

Pre-bid meeting is scheduled to be held at our Zonal Office on 17/08/2024 at 01.30 p.m. Interested bidder(s) can submit their queries / clarifications, suggestions to our purchase committee on scheduled date and time. As a resultant of pre bid meeting any addendum/ corrigendum in bids terms & conditions, if warranted. would be reflected Bank's on (www.ucobank.com) after a day from pre-bid meeting i.e. from 18/08/2024. No paper notification would be made for addendum/ corrigendum in bid document. Interested bidders are advised to go through Bank's website after schedule date for any modification in bid document.

#### (H) Submission of Bid(s):-

Applications are to be submitted to the undersigned in a sealed envelope super scribing as "Bid for Empanelment of Agencies for Maintenance and Installation of Security Equipments" with bidders contact details (address, e-mail & phone no). Bids should be submitted at UCO Bank Zonal Office 5 LLR Sarani, First Floor, Kolkata-700020 on 28.08.24 before 05:00 pm

#### (I) Opening of Bid(s):-

Sealed bids would be opened at our Kolkata Zonal Office, on **29-08-2024**. Bank reserves the right to reject any/all bids without assigning any reason thereto, meanwhile major reasons leading to rejection of bid are specified herein below. Bidders can witness the tender opening process through their authorized representative on schedule date & time. It is not mandatory for bidder to be

present at the time of opening of bids. Bank is also not bound to hold the process of opening of tender due to absence of representative of any or all of the bidders at the time of opening of bids. Bids received after scheduled date & time would not be considered for opening. Sealed bid(s) along with tender fee (if deposited) would be returned to sender's address shown on outer envelope.

#### (J) Evaluation of Bids:-

Technical bid would be opened first, bidders who qualified in the evaluation of their eligibility bid are only considered for empanelment & evaluation of their price bids. Bank reserves the right to reject any/all bids without assigning any reason thereto. Bidders can witness the tender opening process through their authorized representative of schedule date & time. We are not bound to hold the process of opening of tender due to absence of representative of any or all of the bidders at the time of opening of bids.

- 1. Sealed bids received on or before last date would be evaluated on the basis of eligibility criteria as per **Annexure-I** & checklist **Appendix-III**.
- Documentary proofs in respect of each eligibility criteria would be evaluated, confirmation of Local Address, Executed Work/ Performance would be ascertained by Bank. Only after that the bid would be considered for the next stage of empanelment for the Field/ Security item(s) in which it fulfills the eligibility conditions.
- 3. In the next stage of assessment for empanelment the eligible/short listed bidders would be invited for **Demonstration** of their products, in case the offered products found suitable as per criteria fixed by bank, then only the candidature of the bidder is approved for empanelment. Location of the **Demonstration** will be at **UCO Bank**, **Zonal Office**, 1st FLOOR, 5 LLR SARANI, KOLKATA-700020. Date and time shall be intimated through letter/FAX/e-mail. **Maximum seven days notice will be given for the demonstration**. The short listed vendors will arrange the demonstration and they will participate at their own costs.
- 4. All equipments and accessories used for the demonstration by the vendors should be the one, which has been quoted by them in their Bids as part of the tender document. No chance will be given to re-demonstrate.
- 5. Empanelment would be restricted to maximum 03 bidders for respective item on L-1 rates.
- 6. Price bids of eligible bidders would be comparatively evaluated & lowest bid (L-1) would be decided on the basis of price quoted by bidders in Price Bid-Part 1 and Part 2). Work would be allotted to lowest (L-1) bidder; bank may distribute the work among other eligible bidder/s at the lowest rate. In that case major share of work would be allotted to lowest bidder. Bank reserves the right to negotiate with lowest bidder.

#### (K) Rejection of bids: -

Bank can reject the bids in following cases: -

- 1. Late receipt bids, received in open envelope, received through e-mail.
- 2. Bids not having proper documentary proofs establishing eligibility of bidder.
- 3. Bids not provided with requisite tender fee.

- 4. Copies of work order/ contract submitted in proof of experience are not supported by performance certificate from client.
- 5. Work/ services of the bidder found unsatisfactory on confirmation from their client.
- 6. Product offered does not meet the required specification as evaluated during demonstration.
- 7. Bank can reject any or all of the bids without mentioning any reason.

#### (L) Performance Security & Earnest money deposit:-

- 1. Empanelled bidder will be required to submit the Earnest Money Deposit (EMD) with price bid @ of 1% of the estimated cost of work or at applicable rate as prescribed by Govt. / Bank's guidelines before allotment of work order.
- 2. The selected bidder will be required to provide performance security @ 3% of cost of work or at applicable rate as prescribed by Govt. / Bank's guidelines at the time of contract or issuance of work order.
- 3. The proposed work order/contract with selected vendor would include suitable clause on uptime of security equipments, penalty for default to regulate the quality of work / service.

#### (M) Termination of contract or work:-

The Bank reserve its right to terminate the maintenance and supply contract at any time after giving due notice of **one month** without assigning any reason. The contractor will not be entitled to claim any cost and compensation against such termination. However, while terminating the contract, if any payment is due to the contractor for maintenance/ work already performed up to satisfaction in terms of the contract, these would be paid to it/ him as per the contract terms.

#### (N) The Bidder's Indemnity and Assurance:-

- 1. The Bidder should comply with all legal requirements and obtain such licenses, approvals and consents, if any prescribed/required under any law/rules/regulations, and keep them valid.
- 2. The Bank will not be liable to pay any remuneration or compensation to the Bidder or any of the personnel (including its owner(s), director(s), partner(s), employee(s) and any representative(s) engaged by the Bidder in relation to the service except the total cost of the security system as per agreement and AMC charges as per agreement.
- 3. The Bidder to indemnify against all losses, liability or obligation arising out of its conduct or that of any of the personnel including its owner(s), director(s), partner(s), employee(s) and representative(s) in connection with the work to be offered to selected vendor.

#### (O) Other Terms & conditions:-

- 1. For any queries, bidder may contact on working days between 10.00 A.M. to 05.00 P.M.
- 2. Bank is not responsible for any typographical mistake in the tender documents, late receipt bid or damage of bid in transit.
- 3. Tender is valid up to three (3) months from the date of publication.

4. Any dispute arising in this matter will be settled in the jurisdiction of Kolkata, West Bengal.

#### (P) Black-listing:-

Black-listed vendor/firm/agency should not participate in this tender. An undertaking signed by authorized signatory in this regard must be submitted. If in future it comes to Bank's notice that the vendor/firm/agency has been blacklisted by any Bank/ PSU/ Govt Body etc, then the empanelment will be terminated without any notice.

Bidder should not be debarred for participation in tender process in any of our zones (UCO Bank) on account of poor services.

# ELIGIBILITY CRITERIA OF BIDDER FOR EMPANELMENT FOR INSTALLATION & MAINTENANCE OF SECURITY EQUIPMENTS (CCTV, ALARM SYSTEM & FIRE EXTINGUISHERS) IN THE BRANCHES/ OFFICES UNDER UCO BANK, KOLKATA ZONE.

#### A. Experience in execution of required work and performance certification by client(s).

- **a)** The bidder should have experience in executing the similar work as under at Public Sector Banks/RBI/Govt Organizations/PSU:
- i. **Three similar** completed works costing not less than the amount equal to 40% of the estimated cost within seven years ending last day of the month previous to the one in which applications ore Invited in execution of similar works. or
- ii. **Two similar** completed works costing not less than the amount equal to 50% of the estimated cost within seven years ending last day of the month previous to the one in which applications are invited in execution of similar works. or
- iii. One similar completed work costing not less than the amount equal to 80% of the estimated cost within seven years ending lost day of the month previous to the one in which applications are invited in execution of similar works.
- **b)** Audited account and Balance Sheet for last 3-years.
- c) Total Annual Turnover in last 3-years Company should be profitable.
- d) Name & Address of Bankers with solvency certificate. (for project value more than Rs. I.O crore)
- e) Inspection & Testing facilities & procedure in case of purchase of Machineries/equipments.
- f) Availability of fully equipped service centre locally in case of purchase of Machineries/equipments.
- g) No. of service centres in the country in case of purchase of equipments/machineries.
- h) Possession of **PAN card**, **GST registration certificate**, and other registration certificates/ licenses, if necessary, as per Rules of local Statutory Authorities.

Pre-Qualification applications should be submitted in two parts i.e.

#### i) Eligibility Bid

#### ii) Technical Bid.

In the eligibility bid, financial criteria should be included along with other requirements. It should be ensured that pre-qualification criteria are completely spelt out in clear and unambiguous terms. The Technical bid of the eligible vendors/contractors/suppliers who have qualified in the eligibility bid, shall only be considered for opening. After scrutiny and short listing of **Pre-qualification** applications with regard to pre-fixed eligibility criteria, the Techno-Commercial **Committee** will forward its recommendation for empanelment of at least four vendors/contractors to the Competent Authority. lf the number vendors/contractors recommended for empanelment is less than 4, the reasons should be properly recorded and approved by the Competent Authority. However, too many vendors/contractors may not be empaneled and the empanelment may be restricted to maximum 10 vendors/contractors in accordance with the merit towards fulfillment of eligibility criteria in a descending order.

Pre-qualification applications is not applicable for the single bid tenders invited among empaneled vendors of for obtaining seal quotations or from retailers/manufacturer where work/purchase value is less than Rs.5.00 Lakh.

Documentary proofs for the above like Annual Maintenance Contract(s)/work order(s) and performance certificate(s) of each allotted work/contract issued by respective client Public Sector Banks/RBI/Govt. organizations/PSU must be provided with bid to establish the eligibility of Bidder. Bid without minimum required work order/contract and their performance certificates as above would be treated as **ineligible**. Work order/contract not supported by its performance certificate would be treated as NULL.

# B. Certification of performance by client(s) Public Sector Banks/ RBI/ Govt. organizations/ PSU:

- 1. Each work order/ contract submitted as warranted above must be supported by performance certificate(s) as per Appendix- IV of this tender document. Performance certificate should be duly filled on letter head of the clients, signed by the officials dealing in procurement/ maintenance of Physical & Digital Security equipments (preferably Security Officer).
- 2. Bank can confirm the genuineness of the performance certificate issued by client at its own sources. In case the authenticity of performance certificate or work order/ contract found uncertain, the tender of the bidder would be rejected.
- **3.** Performance certificate issued by client would be taken as the proof of the nature of work done, no. of branches/ offices/ sites covered & period of contract, quality of equipments installed, level of after sale services & relationship with the client as far as terms of contract is concerned.
- **4.** Minimum standard for eligibility for bidder as confirmed from performance certificate by clients should likewise:
  - **a.** Equipments installed should be as per specification provided by clients.
  - **b.** Average time taken in defect rectification should be within 24 hrs in Metro & 48 hrs in else time taken in new installation should be within 07 days.
  - **c.** Instances of imposition of penalty should be less than three in the period of contract.
  - **d.** Bidder should not be indulged in arbitration/ court case with the client.
- **5.** Provide list of clients and their contact details to ascertain the genuineness of quality of services bidder have rendered. In case work/ services of bidder found unsatisfactory in any of the work/ contract, their bids would be treated ineligible.

### C. Certification by Original Equipment Manufacturer (OEM):

- 1. Bidder should be the authorized equipment manufacturer/ assembler or have authorization from OEM for consistent supply/servicing of spare/equipments for next 3 years.
- 2. In case bidder is the Original Equipment Manufacturer (OEM), bidder have to provide certificate (as per Appendix-I) about manufacturing of product, genuineness of the products and after sale services & supply of accessories.
- 3. In case bidder is not the OEM, the bidder will have to essentially mention the name of the Original Equipment Manufacturer (OEM) whose product is to be supplied and the country of origin of the product along with technical specifications. Bidder

will also to have certificate in respect of country of origin of products. Product offered should be manufactured in India. Bidder has to submit a certificate from the original equipment manufacturer (OEM) that they are the authorized agents for the sale and service of their product and manufacturer undertakes to support the after sales service of the product. Bidder should provide manufacturer authorization form (MAF) duly signed by the OEM in the name of bidder (Appendix-II).

- 4. All new installed products will stand for onsite comprehensive warranty against all defects in warranty period. During the warranty period the Bidder shall have to provide quarterly preventive service and shall have to attend to all breakdown calls within 24 hours and 48 hours for remote area branches.
- 5. Bidder have ability to provide security equipments of similar or higher technical specifications fixed by bank. The products offered should be manufactured in India.
- 6. Warrant provided by OEM will prevail.
- 7. The offer must include a minimum two-year warranty from the date of installation of the CCTV and Alarm system at the Bank. The vendor shall be fully responsible for the manufacturer's warranty in respect of proper design, quality and workmanship. The vendor must warrant all equipment/s and accessories.

#### D. Registration, Establishment & Service network:-

- 1. As the major part of work is for 24X7 maintenance of the existing Security Systems in our branches so, bidder should have a local Office in the state of West Bengal preferably in Kolkata. Vendor should have adequate technician and local service center in Kolkata to attend and repair the complaint and breakdown within 24 or 48 hours. (Attach list of present branches with technician name, address and mobile numbers).
- 2. Bidder should be registered under Shops & Establishment act.
- 3. Ability to undertake the work of all branches under Kolkata zone.
- 4. Bidder should have a Certificate of Registration with Registrar of Companies or Registrar of Firms or have a letter of proprietorship.
- 5. Bidder should provide the latest Income Tax Assessment Order and PAN/ TAN Number.
- 6. Bidder should have GST registration.
- 7. The vendor has to give an undertaking that
  - I) Hard Disk they will supply is a surveillance Hard Disk (Seagate/WDD).
  - II) DNS software & Remote Health Monitoring Software has to be provided free of cost by the Vendor.
- 8. The Vendor is advised to submit the Bid strictly in accordance with the terms and conditions of RFP and adhering to the Technical Specifications contained in the RFP documents, and not to stipulate any deviations. Bid containing deviation from the terms and conditions are liable to be rejected.
- 9. Bid submitted by firms who do not fulfill eligibility criterion will not be considered for acceptance. UCO Bank reserves the right to accept or reject in full or in part any or all Bid/offer without assigning any reason and without any cost or compensation there for and any decision of UCO Bank in this regard shall be final, conclusive and binding on the offers.
