



Tender should be accompanied with **Earnest Money Deposit (EMD) of Rs. 15000=00 (Rupees Fifteen Thousand Zero Hundred Only)** in the form of **Demand Draft in favour of UCO Bank, Zonal Office, Nagpur**. Tenders not accompanied with EMD shall be rejected and considered invalid. The earnest money shall be returned to the tenderer if the tender is not accepted but without any interest. Items against which no rate is entered by the tenderer will not be paid for by the Owner when. Executed and shall be deemed covered by the other rates in the Schedule-B. If any of the documents is missing or unsigned the tender shall be considered invalid.

9. All erasures and alterations made while filling the tender must be attested with initials of the Tenderer. Overwriting of figures is not permitted. Failure to comply with either of these conditions will render the tender invalid.
10. All the pages of the tender documents should be signed by the tenderer.
11. Within Seven days of the receipt of intimation from the Owner of acceptance of his/ their tender, the successful tenderer shall be bound to implement the contract by signing the agreement in accordance with the draft agreement and the conditions of contract with the owner.
12. The security deposit shall be kept with the Owner for a period of 12 months after the Architect issues the completion certificate which amount is not to bear interest.
13. The rates quoted by the contractor should include all charges for scaffolding materials labour, hire for any tools, marking out and clearing of the site as mentioned in the specifications. The rate quoted by the tenderer in the Schedule-B of probable quantities will be deemed to be for the finished work to be measured at site. The rates shall be inclusive of all VAT, sales tax, octroi duty; works contract tax, Provident Fund, Insurance etc. levied by any Government or any public body. The contractor shall abide by the rules of Minimum Wage Act and Child Labour Act and keep the work as required under the workman compensation act, labour laws etc. as prevailing.
14. The rate shall be binding to the Contractor, for all the tender items till the completion of the work Irrespective of variation in market rates of material and labor.
15. The calculations made by the tenderer should be based upon probable quantities of the several items of work, which are furnished for the tenderers convenience in the schedule B. It must be clearly understood that the contract is not a lump-sum contract that neither the probable quantities nor value of the individual and the aggregate value of the entire tender will form a part of the contract and that Architect doesn't in any way assure the tenderer or guarantee that the said probable quantities are correct or that the work would correspond thereto.
16. The items against which no quantity is shown in schedule-B for which tenderer is to quote his rates and the Owner at his description shall ask the contractor to execute those items if required and which shall be binding on the part of the contractor to execute those items at the rates quoted therein in the tender.

18. The successful tenderer should make his/ her own arrangement to obtain all materials required for the work.
19. The various materials stored on site shall be protected from the fire, floods or rains etc. and the contractor shall be responsible for any damage caused to the owner for the same.
20. The contractor shall allow enough facilities to the sub-contractors employed by the owner and should co-operate with them and that small holes etc. made by these sub-contractors to the structure shall be properly corrected by the general contractor without any prejudice and extra cost whatsoever.
21. The bills shall be prepared by the contractor in the manner required by the Architect and should be submitted to him. The owner shall pay the contractor within the 15 days time from the issue of the certificate of payment by the architect. All payments by the owner under this contract shall be made at Nagpur Zonal Office.

GENERAL SPECIFICATIONS FOR WORKMANSHIP AND MATERIALS:-

1. The workmanship has to be of the best quality to the satisfaction of the Competent Authority. The entire premises shall be well cleaned before the job is handed over.
2. The exposed edges of the plywood shall be properly covered with the laminates or lipping and no edges shall be left unlipped. All the joinery shall be neat and joinery of plywood shall be "dove - tailed" type and always fixed with proper screws and adhesives (Favicol / Falco fix or equivalent) and no nails shall be used for joinery.
3. For all the woodwork the wood surfaces shall be made absolutely "smooth and even" by planning thoroughly & baitha.
4. Pressing of laminates shall be in a workman like manner ensuring **no air pockets** with clean edges. All the details on the woodwork like grooves and molding etc shall be neat and clean and in proper line and level. For all polishing works, the surfaces shall be prepared absolutely smooth and the finishing done in a workman like manner.
5. Plywood used shall be got approved before use. **Century Ply (i.e. Architect Ply, Club Prime, Bond-710), Green Ply (i.e. Green Gold, Green-700, Green Club-500), Duro Ply (i.e. Duro Techply), Kit ply (i.e. Kit Ply-PF-710) or as directed by Architect.**
6. All teakwood exposed shall be of good quality and shall be got approved before use. The basic rate of teakwood Rs. 4500/-/ per cu.ft. Inclusive of all taxes.
7. Laminates shall be of standard quality (1.0mm thk.) **Century Lam / Greenlam (701 Rising Beech) & (Celestial Blue-292) / Sunmica (Sapphire Blue-G452) / Archid Lam / Formica (Sugar Maple-1758) or as directed by Architect.**
8. All glasses shall be of 6mm, 10mm & 12mm thk. All clear glass shall be of Modi Float / Asahi Float / St. Gobain float glass only. All exposed edges of glass shall be Machine polished, beveled & smooth as per the quality requirement of the Competent Authority.
9. All fittings and fixtures shall be of best quality, heavy type brass oxidized or chromium plated as per Competent Authority requirements and specifications. All storage locks, tower bolts, hinges, ball catches, telescopic sliding channels (Earl-Behari/ Godrej/ Hettich make) and handles as per approval of the Competent Authority.
10. Door fittings shall include handles, heavy duty brass hinges, with night latch (wherever mentioned) / Aldrop / mortise locks directed (in brass chrome or oxidized,) door stopper and shall be supplied and fixed by the contractor.
11. All above hardware shall be approved by the Competent Authority before use.
12. All exposed T.W. members shall be finished with wood polish.
13. **All Drawer sliders / Keyboard sliders shall be telescopic channels / sliders only.**
14. All Concealed locks to the doors shall be of Godrej make only.


