UCO Bank Tender Notice

UCO Bank invites sealed tenders in a two-bid format (Technical Annex A,B,C,D & Financial Annex E) from vendors for the construction of a Temporary Branch and four double bed room accommodations at Maha Kumbh, Prayagraj 2025, as per the specifications and requirements outlined below.

1. Urgency of the Tender:

The tender ref no ZOV/GAD/ZOPC/24-25/Tender/01 dated 10.12.2024 was floated with a 7-day timeline and extended further more two days after publishing corrigendum notice dated 20.12.2024 but was cancelled, and a notice was published on the website on 24.12.2024 due to the receipt of an L1 bid exceeding the estimated amount. Considering the limited time remaining and with the consent of the members, the retender notice is being floated with a reduced notice period of three days. The Maha Kumbh 2025 is scheduled to commence on 13th January 2025, making the completion of the project highly time-sensitive. To ensure timely execution, the tender is proposed to be floated for only three days.

2.Tender Details:

The project involves constructing a temporary branch and four tent-room accommodations with the following specifications:

Temporary Branch from 06.01.2025 to 27.02.2025: Includes 3 counters, a separate partition for the Branch Manager with washroom, and a total area of 1800 sq. ft. (35X51.43 ft).

Accommodation Facilities from 06.01.2025 to 27.02.2025: Four bedrooms with attached toilets, a pantry, and a visitors' lounge.

Additional Facilities: Complete electrical wiring, plumbing, furniture, and other necessary installations (refer to the detailed tender notice for specifications).

Specifications (RFP):- Construction of the branch elevation with replica of Head Office Kolkata.

1. Architectural Specifications: The front elevation of the branch building should match the design of the UCO Bank Head Office building in Kolkata.

4. Gernal Guidelines mentioned below;

- a. All empanelled vendor by Prayagraj Mela Pradhikaran for Mahakumbh 2025, shall be eligible to apply in the tender process. Valid Letter of empanelment issue by the competent authority of Mela Pradhikaran needs to be submitted. It is pertinent to mentioned here that period of empanelment should be mentioned clearly by authority.
- b. Bidders who are not empanelled by Prayagraj Mela Pradhikaran but having experience in the similar activity during Magh Mela/Ardh kumbh/Maha kumbh are also eligible to apply for the same subject to the submitting of work completion certificate/report by the related competent authority.
- c. The Applicant should be a Company registered under the Companies Act

or Partnership firm registered under the Partnership Act of 1932 or registered (converted to) under the Indian Limited Liability Partnership Act, 2008 or a Proprietorship.

- d. The Applicant should have experience in construction of Bank Premises & other financial institutions with Tentage/temporary structures in Magh Mela/Ardh kumbh/Maha kumbh during the last 15 financial years ending 31st March 2024, (Work Orders/completion certificates from client should be submitted for the same.Similar Work means construction of Tentage/temporary structures in Magh Mela/Ardh kumbh/Mahakumbh etc.)
- e. Certificate of registration with Income Tax (PAN No.)/Revenue authorities (GST No.). Any other registrations with Local authorities/State/Central Government, Labour licenses, EPF, ESIC, Factory license etc. shall be submitted along with tender documents.
- f. Details and certificate of Empanelment /Registration with Govt.Central or State/Public Sector Units/ Banks etc.for similar type of contract /work should be summated along with the tender documents.
- g. Details of involvement into iitigation, if any, in similar types of contract should be summited along with the tender documents.


