Invitations of bids for Purchase of Note sorting Machine & Note Authentication Machine/Value counter

Bids duly sealed & properly super scribed are invited under two bids system as per the format given at appendix –II (Technical bid) and appendix – III (Financial Bid) for purchase of Note sorting Machine & Note Authentication Machine. Technical Specifications of required NSM/NAM/value counter. General terms and conditions are as under:

Terms and conditions for Bidders:

Closing date of tender 20.12.2023, 1600 hrs. Tender received after due date and time will not be entertained.

Opening date of tender 21.12.2023 Both Technical and Financial bids.

Envelop should be super scribed as "TENDER FOR NSM/NAM/VALUE COUNTER" and addressed to 'Zonal Office UCO Bank, General Admin Department, Himland Annexe, Circular Road, Shimla (HP)

Rates quoted by the vender will be inclusive of all freight, transportation, labour, installation and other expenses supposed to be incurred until final delivery on the specified location. However, GST will be quoted separately.

Rates for Buy Back items are required to be quoted compulsorily wherever applicable. Final rates of that particular NSM will be considered after deducting the rates of buy back item.

Every vender will endorse sign and seal on all pages and submit the tender on the given address before the last date/time of submission of the tender.

In case of unscheduled holiday on the closing/opening day of bid, the next working day will be treated as scheduled prescribed day of closing/opening of the Tender.

Bidders are advised not to indicate any separate discount. Discount, if any, should be merged with the quoted prices.

The lumpsum price must be quoted in figures as well as in words without any cutting or overwriting.

In case any discrepancy in the rates quoted in figure and words, the rates quoted in words shall be considered as final and authentic.

The lowest Bidder will be identified after deducting Buy back price of old NSM/NAM/VALUE COUNTER and order will be given to the L1 bidder only.

Supply Order will be placed branch wise and payment will be made by the branch within 21 days from the date of receipt of clear and undisputed invoice/bill after satisfactory completion of work. The invoice/bill is to be raised in the name of concerned branch.

Time Frame for the supply of NSM will be 20 days from issuing supply order. No extension in time will be given at any cost. If vendor fails to deliver the NSM within due time than late delivery penalty amounting to Rs 250/- per day of delay will be deducted from the final bill and security fee will be forfeited

Rates quoted by the vendors will be valid for One year i.e. upto 30th DECEMBER 2024. Bank has right to place more orders as per the requirements arises in future on the same rates and terms & conditions. However, Location of branches may be different within Himachal Pradesh.

OEM can assign the job of supply and installation to their authorized channel partner/distributor. However, OEM will be required to issue a certificate regarding authorization of channel partner.

Brochure with features & specification of quoted NSM & NAM to be provided with Tender docs.

GST Registration certificate to be furnished with tender papers.

Bank reserves the right to cancel or amend the complete tendering processes at any stage and also reserves the right to cancel L1 bidder or any other bidder without showing any reason.

NSM & NAM To be supplied must be new brand and not be refurbished. If it is found as such like within one year of its installation, it will be returned to the supplier/vendor and absolutely new unit will have to be reinstalled by bearing all related cost of reinstallation by the supplier Vendor.

A list of authorized Service Centers of OEM with addresses and contact details to be submitted with the Tender documents.

The Bidders shall submit the EMD, Tender processing fees and Technical Bids (all) in one sealed cover and the Financial Bids (all) in another sealed cover duly superscribed, then these sealed covers are to be put in a bigger cover and should also be sealed and superscribed "Tender for Purchase of "NSM & NAM". All sealed covers are to be addressed to "The Zonal Manager, UCO Bank, Zonal Office, Hotel Himland Annexe, Circular Road, Shimla, Pin 171001" and will be put in the Tender Box provided at the above address by 1600 hrs on or before 20.12.2023. Conditional Bids will be summarily rejected. Each bidder shall submit only one bid. In case a bidder submits more than one bid, then all bids submitted by that bidder will be summarily rejected. Part II (Financial Bid- APPENDIX-III): Financial Bids will be opened on the same day at 1600 hrs at the same address.

Part II will be opened only if Bank is satisfied with Part I. Bank reserves the rights to reject any/all bids without assigning any reason thereto. All pages of the tender should be signed and stamped by the vendor while submitting the tender.

The Tender document fee of Rs.2000/- (Rupees two thousand only) (Non-refundable); the Earnest Money Deposit (EMD) Refundable Rs. 10000.0 (Rupees. Ten thousand) are to be enclosed in the form of Demand Drafts/pay orders drawn separately in favour of 'UCO Bank, Zonal Office, Shimla' payable at Shimla, with the Technical Bid, failing which the tender will be rejected.


