- 3. Contractors applying for empanelment under category "B" & "C" should have successfully executed at least two similar works in the relevant trade at least up to 75% of the upper limit of the particular financial category during last three years.
- 4. Average annual turnover of last three years

Category – B: Rs.30 lakhs Category – C: Rs.50 lakhs Category – D: Rs.100 lakhs

- 5. The applicants should have their office / establishment in Rajasthan.
