- 1. L1 Bidder will be selected based on the total least cost quoted for the software mentioned in the table (T3)
- 2. All the software as per the scope to be renewed annually well in advance before the expiry of the ATS period.
- 3. TDS will be deducted as per rules applicable.
- 4. Bank will pay taxes ruling at the time of actual delivery of software/services/implementation and resultant billing.
- 5. Bank reserves the right to utilize ATS support as per the requirement of the Bank.
- 6. If in future, Bank wants to renew the ATS of any system software (Oracle/ IBM/ Microsoft) for which price is discovered as part of this RFP, the selected bidder has to renew the same as per the price finalised.
- 7. Bank wants to have a common end date for all the software which are part of this RFP. The common end date is 31st Dec. Hence the vendor to quote accordingly till 31st December 2021. For Example if a license expires on 8th Feb 2017 then the bidder to quote for the part period till 31st Dec 2017 and then annually for the next 4 years till 31st Dec 2021. For licenses where common end point is not possible bidders to quote till 31 Dec 2021.
- 8. Any variation in applicable taxes, whether resulting into increase in rate of taxes or levy of new tax or reduction in rate of taxes or abolition of existing taxes due to a new tax legislation or otherwise, shall be borne by the Bank.
