- Applicant will be required: (i) to provide proof of ownership along with application and (ii) NOC for opening of bank/ATM from Competent Authority at their own cost at the time of finalization.
- The offerer must have a clear title to the property. Bank shall obtain title opinion from Bank's panel advocate and the offerer should bear all costs in this regard.
- Premises should preferably be located on ground floor. There could be few exceptions like premises in Malls, Shopping Centre etc. where infrastructure facilities like lifts, escalators are available.
- The premises must be suitable from the security point of view and have all basic amenities such as adequate sanitary arrangements, water and electricity, natural light and ventilation.
- The premises structure should be strong enough to bear the weight of Strong Room, Strong Room Doors, Safe & Lockers Cabinet. Strong Room to be constructed as per Bank's specification. Bank will provided strong room door, air ventilator and exhaust fan. The landlord should bear all cost related to construction of strong room. Land lord should provide collapsible gate at the entrance of the Branch at his cost.
