SCOPE OF WORK

Bank intends to select bidder for procurement of additional hard disk/storage for Augmentation of existing storage (Dell SC4020) which is under existing AMC valid upto Oct 2021 for existing Dell Server. At present, database server and storage device is of DELL (Manufacturer) of 35 TB capacity. To have a compatibility with existing server and storage, selected bidder may supply required hard disk of total capacity usable 40 TB in RAID 5 of same make and model or any compatible model of new Storage of same make at Bangalore and Kolkata in capacity of 75 TB at each location.

The Selected Bidder is required to deliver, install and maintain the following hardware:
