Intending bidders are advised to conduct search in Revenue / SRO records to satisfy title, identity, extent, dimensions, survey number, door number, boundaries or encumbrances in regard to the property proposed to be sold.
- 2) Intending bidders shall hold a valid Digital Signature Certificate (Class II / Class III). Interested bidders to access the portal / website of the e-Auction Agency (viz., <a href="https://ucobank.auctiontiger.net">https://ucobank.auctiontiger.net</a>) and register themselves for getting User ID and Password.

- 4) Bids should be submitted along with a copy of identity document as an attachment to the bid form.
