3. Contractors applying for empanelment under category “B” should have successfully executed at least two similar works in the relevant trade at least up to 75% of the upper limit of the particular financial category during last three years.
4. Average annual turnover of last three years for Category – B: Rs.30 lakhs
5. The applicants should have their office / establishment in Rajasthan.
6. The applicants for housekeeping should have sufficient numbers of personnel to manage the work efficiently.
7. Contractors applying for the trade of Electrical work should possess the valid Electrical contractor’s license, issued by competent authority, in the name of the contractor or employee of the company. Photocopy of such license should be submitted with the application. (as per annexure – II)
8. Contractors / vendors applying for the trade of Operation / maintenance services of air conditioning machines should have vast sound experience of operation & maintenance of all kinds of air-conditioning units.
