- (ii) Earnest money of Rs. 1500/-(Rupees One thousand five hundred only), for each Inverter, in the form of DD/Ray Order drawn in favour of "UCO Bank" and payable at JORHAT.

There should not be any indication of price/rate/charges in Part-I of the tender. Conditional tenders will be not accepted.

- Part-II of tenders should be submitted in separate sealed cover, superscribing "PART-II (Price Bid)". Part-II of tenders should contain the rates as per the Bill of Quantities (BoQ) format at the end of this document.
- 3. Separate sealed envelopes containing Part-I and Part-II of tenders should be put in another sealed cover superscribing "OFFER FOR OURCHASE OF INVERTER". Such envelope should reach at above mentioned address of our Office by 3:00 pm on 01.10.2022.
- 4. Part-I of tenders will be opened at 3:30 pm on 03.10.2022 in presence of representatives of participating tenderers who intend to remain present in the tender opening process. Part-II of all unconditional tenders, which comply the requirements/conditions of Part-I, will be opened thereafter on the day in presence of attending representatives of participating tenderers.

Eligibility Criteria:

Bidder must provide document(s) in support of each of the following along with his tender:

- The bidder must be a OEM or Authorized Supplier of OEM and should be a registered company in India under Companies Act 1956 or amended Companies Act 2013.
- 2. The bidder should be a profit making company /firm (Profit before Tax) in last three financial years.
- 3. The bidder must be registered under GST.
- 4. The bidder should have PAN.
- 5. The bidder should have experience in executing the similar work as under at Public Sector Banks/ RBI/ Govt Organizations/PSU:
- a. Three similar completed works costing not, less than the amount equal to 40% of the estimated cost within seven years ending last-day of the month previous to the one in which applications are invited in execution of similar works.
- b. Two similar completed works costing not less than the amount equal to 50% of the estimated cost within seven years ending last day of the month previous to the one in which applications are invited in execution of similar works. **or**
- c. One similar completed work costing not less than the amount equal to 80% of the estimated cost within seven years ending last day of the month previous to the one in which applications are invited in execution of similar works.
- 6. The bidder should have well equipped registered Service Centre at nearby locations.

Terms and Conditions:

- I. The rates quoted in the tender must be inclusive of all taxes, duties, delivery & installation, racking and placing charges at site.
- II. Installation: Within 2 weeks from the date of issue of work Order.
- Warranty: Minimum two years comprehensive warranty for inverter and 4 years for battery.
- IV. Payment Terms: After satisfactory supply, installation, testing & commissioning of the item subject to statutory deductions as per Rule. 10% will be deducted before release of payment and will be kept as Security Deposit and will be released after defect liability period of one year from the date of Installation without any interest if there is no damage claim.
- V. Vendor should enclose the technical specification/catalogue/brochure of their specified model with the quotation.
- VI. Vendors other than manufacturer of inverter has to submit their dealership/distributorship certificate from the manufacturer along with quotations. Submission of dealership/distributorship certificate from the manufacturer of battery is preferable.
- VII. The Bank reserves the right, not to execute the full quantity of items, as mentioned in schedule of quantities.

COMPREHENSIVE ANNUAL MAINTENANCE CONTRACT CHARGES:

Bank will go for Comprehensive Annual Maintenance Contract (including all spare parts) @ 5% of bill value (excluding GST) of machine in each year for a period of three years after expiry of warranty period.
