

- Application will be required : (i) to provide proof of ownership along with application and (ii) NOC for opening of bank along with ATM from Competent Authority at their own cost at the time of finalization.

- Premises should preferably be located on ground floor. There could be few exceptions like premises in Malls, Shopping Centre etc. Where infrastructure facilities like lifts, escalators are available (only for branch space).
- The premises must be suitable from the security point of view and have all basic amenities such as adequate sanitary arrangements, water and electricity, natural light and ventilation.
- The premises structure should be strong enough to bear the weight of Strong Room, Strong Room Doors and Safe & Lockers Cabinet. **Construction of Strong Room as per Bank's specification should be done by the Landlord.**
