C) <u>Bidders required to submit</u> their application to the undersigned in three sealed covers -<u>Eligibility Bid</u> in sealed envelope superscribing "PART-I(Eligibility Bid)", <u>Technical Bid</u> in sealed envelope superscribing "PART-II (Technical Bid)", and Financial Bid in a separate sealed envelope superscribing "PART-III (Financial Bid)". All the three Parts of Bids will be submitted in one sealed envelope superscribing "Empanelment of Vendor for Annual Maintenance & Refilling of Fire Extinguishers at the Bank Branches under Zonal Office, Jorhat" along with the Vendor's complete Address and Contact Number. In no case Financial Bid will be submitted in open condition.

(1) Part I. - Eligibility bid - to include profile of the company.

a) List of major existing (State Govt., Central Govt, PSU, RBI, Public Sector Banks) clients, registration number and GST details etc. as mentioned in Appendix-I point-wise. Attach documents wherever required.

b) EMD shall be Rs. 5,000/-(Five thousand only) to be deposited along with Tender Document through Demand Draft in favour of UCO Bank, Zonal Office, Jorhat. EMD shall be retained for a period for one year from the date of issue of work order. No interest shall be paid on the EMD.

(2) Part II. Technical bid - to meet the technical specifications: Compliance of technical specifications of Fire Extinguishers given in **Appendix –II** point wise.

(3) Part-III - Financial Bid: Net rates (inclusive of all taxes, levies) as mentioned in Appendix-III.

Please Note: Financial Bids will be opened of those bidders only, who will have successfully qualified Part-I and Part-II.

D) Financial Bids shall be opened in the presence of vendors' representatives. If the representative shall not be present at the time of opening of bids, L-1 will be selected exparte.

E) In case our office is declared closed on the last date of receipt or pre-decided date of opening of tender due to holiday/ Bandh call /Lockdown etc., the respective date shall be treated as deferred/re-scheduled to the next working day.

F) It may be noted that the requirement given in this RFP is indicative only.

G) Tender /Offers sent through Fax and E-mail will not be accepted.

H) Bank reserves the right to accept / reject in part or in full any or all offers without assigning any reason at any stage whatsoever and without any cost or compensation and any reason therefore. Any decision of UCO Bank in this regard shall be final, conclusive and binding on the bidders.

I) Service contract period for maintenance including refilling of existing Fire extinguishers with L1 bidder will be decided by the bank (minimum for the period of one 01year). However, depending on the performance the work order may be renewed or terminated. In case of termination, work order shall be allotted to another empanelled Vendor for the next period. New AMC rates including refilling will be fixed and non-negotiable for 3 (Three) years and no revision will be permitted before end of this period.

J) The empanelment period for the empanelled vendors will be for a period of 05 (Five) years. However, if our Head Office or any higher office of UCO Bank conducts Pan India Rate contract, Zonal office, Jorhat will have the right to cancel this Rate contract. In such case notice of one month will be served to the firm for termination of Rate contract and no other claims will be entertained.

K) All Branches/Offices/ATMs have Fire Extinguishers. They all fall under the maintenance & refilling of fire extinguishers.

L) Fire Extinguishers kept inside ATM attached to concerned branch will be included in Branch count, which will be refilled and maintained with Fire Extinguishers of respective branch and no separate visit will be counted for the ATM visit, whether it is located near or far from Branch location.

M) Please read carefully all the points of this RFP and duly sign on each page with company seal (encrypted Designation with name of the company) as token of acceptance and deposit it mandatorily with the tender documents.

N) Bank reserves the right to award the contract works to single service provider or can engage 02 service providers.

O) Bank reserves the right to consider or cancel the bidding process in the event of dispute.

P) Empanelment of vendors may be restricted to maximum **10 (Ten) vendors** in accordance with merit towards fulfillment of Eligibility criteria, Technical specifications and satisfactory demonstration.

Q) <u>Clerical errors to be rectified:</u> Neither party shall take any advantage of any clerical error or mistake which may creep in or occur in the specifications, schedule of rates, plans, instructions, tenders or any other papers supplied to or by the vendor in connection with the work, but such clerical errors or mistake shall be brought to the notice by the one to the other without any loss of time and same shall be rectified.

INSTRUCTIONS TO BIDDERS: GENERAL TERMS & CONDITIONS

- 1. The Fire Extinguishers and all the parts should meet the standard as stipulated under Technical Specification.
- 2. Ability to undertake the work and maintenance of all branches throughout Jorhat Zone.
- 3. Ability to provide Fire Extinguishers as per technical specifications and details available at **Appendix-II** of this advertisement.
- 4. Ability to commence service within **15 days** from date of placement of order.
- 5. The vendor should meet the eligibility criteria, other requirements as per details available at **Appendix-I** of this advertisement.
- 6. The components/ parts/ accessories used in the Fire Extinguishers shall have to be new & original. Refurbished/duplicate/used components/parts shall invoke the performance in case such accessories are found installed/supplied in the Bank. The vendor will also provide guarantee that all the components supplied by them are licensed & legally obtained and belong to reputed companies manufacturing Fire Extinguishers.
- 7. If L1 bidder fails to comply with the work order, Bank can consider offering work order to L2 bidder on Rates and Terms and Conditions of that of L1 bidder.
- 8. All Products, for which BIS standards exist, should confirm to the latest BIS standards. The materials should have warranty against any bad workmanship for a period of 03 years (three years). Any defects found within this period are to be rectified immediately by the company free of cost.
- 9. Firms shall not be owned or controlled by any Director or Officer/employee of the UCO Bank or their relatives having the same meaning as assigned under Section-6 of the Companies Act 1956. (A certificate denying the ownership of Agency/Firm/Manufacturer/Dealer by any director or officer/employee of the Bank or their relatives having the same meaning as assigned under section 6 of the Companies Act 1956 issued by the CEO or Director of the Firm to be submitted along with the tender).
- 10. Firms should submit an undertaking (on their letter head) duly signed by authorized signatory with company seal that they have not been blacklisted by any Govt. Authority or PSUs/PSBs.
- 11. Bank is not responsible for late receipt of application or its damage in transit.
- 12. Any dispute arising in this matter will be settled in the jurisdiction of Jorhat Distt (Assam).
- 13. All branch visiting technicians should be verified by local Police. (Police verification reports to be provided)
- 14. Vendor should have adequate technicians to attend to complaint and breakdown within 24 hour in branches under Jorhat Zone. Give the exact number of technicians working in your concern and their contact nos.
- 15. The selected Bidder shall be responsible for the OEM's warranty for all components constituting the system(s) against any defect(s) arising from design, materials, manufacturing, workmanship of assembling or any action or inaction/ omission on the part of OEM/ vendor or any defect that may develop during day to day use of the equipment/ system(s). It is also clarified that there should be no mismatch or discrepancy in the Proprietorship of the vendor applying for Tender and the entity authorized to provide the services in this behalf.
- 16. Notwithstanding Bank's right to cancel the order, liquidated damages for late installation of the system @ 0.2% of the cost of the item per day per case will be

charged subject to a maximum of 10% of the value of the order. For this matter, meagre delivery & installation will not debar the selected Bidder from enforcing the clause of liquidated damage & till such time the system is made operational, it would be considered as uninstalled. The penalty for late installation will be deducted from the bill amount.

- 17. The Bank reserves the right to reject any or all bids at any point of time prior to the issuance of purchase order without assigning any reasons whatever.
- 18. If, during the warranty period, any system as whole or part(s) thereof fails more than once within a quarter, the vendor has to ensure that an equivalent new equipment(s) replace it free of cost.
- 19. The selected Bidder will not outsource maintenance work to any third party & will arrange attending all complaints through its own service/ support infrastructure or through their principles (OEM).
- 20. The Bank shall impose a penalty up to 10% of the bill(s) if the vendor fails to maintain the above standard of maintenance. Penalty shall be deducted from bill(s) payable by the Branch(s)/Zonal office.
- 21. The vendor has to arrange to issue Identity Cards to the technicians. The technician will carry their ID cards during the Branch visit.
- 22. Terms of payment: Payment to be released from the Branch after submission of final bill / Invoice and Installation Certificate.
- 23. The vendor will submit the Bill & Certificate of work at concerned Branch, after completion of work.
- 24. The contract can be terminated if the work of the contractor is found unsatisfactory, or it turns out in due course that the vendor has misrepresented or concealed the facts in his Tender document. In this connection, the decision of the Zonal office Jorhat shall be final and binding on the service provider.
- 25. On completion of the said work, the Branch functionaries identified by the Branch Head shall be briefed on handling the items satisfactorily. Thereafter, the relevant bill for the work should be submitted to the Branch Head, upon whose verification the bill shall be released. Vendor should confirm that on instance of failure of the device to smother fire, penalty can be imposed.
- 26. Vendor should be capable of refilling the existing fire extinguishers held with branches and offices located in rural, semi urban & urban centers of 16 districts of Assam, 02 Districts of Nagaland and 02 District of Arunachal Pradesh.
- 27. New installation will be done at Branch/ Office locations as per Bank's requirement.
- 28. Vendor/Dealer should submit authorization certificates from Manufacturer Company for supply / maintenance of the equipment which they offered.

ELIGIBILITY CRITERIA OF VENDORS FOR REFILLING AND MAINTENANCE OF FIRE EXTINGUISHERS

- 01. Vendor should have a Certificate of Registration with Registrar of Companies or Registrar of Firms or have a letter of proprietorship.
- 02. Vendor should provide the latest Income Tax Assessment Order, GST and PAN/TAN Number.
- 03. Reputed service providers, specialized in providing and installing Fire Extinguishers for at least last 03 years in the field will be considered with relevant documents.
- 04. Vendor should provide the latest Audited Balance Sheet preceding 03 Years.
- 05. Vendor should provide total annual turnover for last 03 years.
- 06. Vendor should provide the name and address of Bankers with solvency certificate not older than one year. This certificate should pertain to other than UCO Bank.
- 07. Vendor should have a local and functional Office in the State of Assam. Please give postal address & landline contact number for confirmation.
- 08. Vendor should be registered under the appropriate authority for GST.
- 09. Vendor should have provided services of maintenance and refilling of Fire Extinguishers to at least two Nationalized Banks in the state of Assam during last three years.
- 10. Demonstration to be shown only by L-1 and L-2 Vendors of Fire Extinguishers and their accessories. In case of supplies/ installations of the products other than/of inferior quality than as shown in demonstration, a proportionate amount of performance security will be forfeited by Bank.
