1.	Para 2 (a) Page No.4: DGR Registered Agency(s) cannot participate in an Open Tender, hence there is no point in giving weightage to DGR registered agency(s).	Due weightage will be given to any Ex-DGR registered agency. Thus in para 2 (a) Page No.4 and in Format of Self Evaluation at Annexure-VIII the term DGR registered agency to be read as Ex-DGR registered agency.
2.	Para 14 (i) page No.10: Character and Antecedent Verification:- Before deployment of Security Guards, obtaining verification of Character, & Antecedents Certificate by Police is not possible.	For only those security guards whose Police Verification has not been obtained, the receipt copy/acknowledgement of application submitted to Police authority for verification will be submitted. However the matter to be pursued and completed within three months time.
3.	Para 15 page No.10: Fidelity Insurance Cover: As reported by some representative of PSA, Fidelity Insurance does not cover the Principal Employer. Hence, Bank should go for PIP(professional Indemnity Policy)	The matter has been referred to Bank's Law Department and will be suitably included in the Agreement to be signed between PSA(s) and the Bank.
4.	Para 2(V) page No.7: PSA should have Registration & Exemption Certificate from State Security Guard Board wherever applicable: The same is to be included in the checklist of documents to be submitted.	PSA(s) are advised to include the same in Check List of Documents to be submitted while submitting Technical Bid; particularly for the State of Maharsahtra.
5.	Tender Documents downloading and submission of Tender fee & EMD	EOI documents to be downloaded from Bank's website and submitted with Tender Fee of Rs 2000/- in the form of a Demand Draft. EMD to be submitted as a Bank Guarantee.
6.	Empanelment Procedure and PSARA licence	Empanelment of PSA(s) will be Statewise and Financial Bid among shortlisted PSAs will be also Statewise. However guidelines on Central Govt. Minimum Wage will be complied.
7.	There were requests from the representatives of PSAs regarding relaxation of Age limit of Security Guards and also the number of Armed Guards provided to Public Sector Organisations.	The age limit of Armed Guard has been relaxed and it is "should not be more than 52 years of age". PSA should have on its roll minimum 200 Armed Guards out of which at least 100 Armed Guards should have been provided to Banks(either Public or Private Sector) and/or any public sector undertaking.
