The following terms and conditions should be complied with while submitting the offer for the proposed premises:

1. Applicant will be required to provide –
 - i. Proof of ownership along with application and
 - ii. NOC for opening of bank/ATM from Competent Authority at their own cost at the time of finalization.
2. The offerer must have a clear title to the property.
3. Premises should preferably be located on ground floor. There could be few exceptions like premises in Malls, Shopping Centre etc. where infrastructure facilities like lifts, escalators are available.
4. The premises must be suitable from the security point of view and have all basic amenities such as adequate sanitary arrangements, water and electricity, natural light and ventilation.
5. The premises structure should be strong enough to bear the weight of Strong Room, Strong Room Doors, Safe & Lockers Cabinet. Construction for Strong Room as per Bank's specification should be done by the Landlord.
6. The offerer will have to execute Bank's standard lease deed and bear the cost of execution and registration of Lease Deed.
7. The offerer should bear all the taxes, non-conforming/misuse charges, cesses etc. if imposed, related to the premises.
8. The offerer is to provide space for Generator Set, Toilets and Parking space free of cost.
9. The offerer is to provide three-phase power connection with minimum power load of 10 KVA for the purpose.

The cover containing technical detail should be marked envelope no. 1 and super scribed with Technical Bid and the cover containing financial details should be marked as envelope no. 2 and super scribed with Financial Bid. Both these covers duly sealed should be put up in the third cover super scribed with "Offer of Premises for UCO Bank, Branch Name" and it should also bear the name, address and contact number of the offerer on all the three envelopes. The third cover duly sealed should be addressed to the Zonal Head, UCO Bank. Where the offers for premises are for more than one branch, the offers should be submitted in separate covers super scribing each cover with the branch name.

The offer as above should be submitted in the bank's prescribed format only which may be obtained from the aforesaid branches/Zonal Office, Ranchi or downloaded from Bank's website, www.ucobank.co.in.

(Advertisement dated 14.10.2018)

1. (i) Submit your offer in enclosed quotation form in two separate sealed covers, one for technical bid and another for financial bid.
(ii) Please ensure to submit the same to our office latest by 29.10.2018.
(iii) Where the offers for premises are for more than one branch, the offers should be submitted in separate covers superscribing each cover with the branch name.
2. While filing the quotation forms, please ensure to follow below mentioned instructions:
 - (i) Submit copy of ownership document along with technical Bid.
 - (ii) You have to submit copy of "NOC" from competent authority.
 - (iii) Fill up all the information asked for in the enclosed form itself.
 - (iv) Do not quote rent / sale price anywhere in Part I of the form.
 - (v) In case you desire to stipulate any term and condition, the same should be mentioned in Part I of the form.
 - (vi) Each part should be kept in a separate cover and the cover containing technical details should be marked 'Envelope No.1 – Technical Bid' and the cover containing financial details should be marked "Envelope No.2 –Financial Bid'. Both these covers, duly sealed, should be put in a 3rd cover super scribed with "Offer of Premises for UCO Bank".
 - (vii) All the three envelopes should also bear the name and address, phone no./mobile no. of the offerer.
 - (viii) Separate applications as per prescribed Performa, duly filled, signed & sealed, be submitted in respect of each offer. This is applicable for both the bids i.e. Technical & Financial e.g. if any offerer is interested for two offers, he/she/they should submit two separate sealed covers each for Technical & Financial bids (2 nos. for Technical & 2 nos. for Financial Bids) and do the needful as described.
