



The following terms & conditions should be complied with, while submitting the offer for the proposed premises:

1. Applicant will be required: (i) to provide proof of ownership along with application and (ii) NOC for opening of Bank/ATM from Competent Authority of their own cost at the time of finalization.
2. The offerer must have a clear title to the property.
3. Premises should preferably be located on ground floor.
4. The premises must be suitable from the security point of view and have all basic amenities such as adequate sanitary arrangements, water and electricity, natural light and ventilation.
5. The offerer will have to execute Bank's Standard lease deed and bear the cost of execution and registration of Lease Deed.
6. The offerer should bear all the taxes, non-conforming/misuse charges, cesses etc. if imposed, related to the premises.
7. The offerer is to provide space for Inverter/UPS Set, antenna and Parking space free of cost.
8. The offerer is to provide three-phase power connection with minimum power load of 10 KVA for the purpose.
9. Earnest Money Deposit (EMD) amount has to be deposited by the way of Demand Draft of Rs. 10,000.00 (Ten Thousand only) in favour of **UCO Bank, Zonal Office, Jaipur** by bidders in order to become eligible in Technical Bid. EMD of unsuccessful bidder will be released (without any interest) against their request letter after completion of selection process of Lowest One (L-1) bidder. EMD of (L-1) will be released (without any interest) after execution of lease agreement. However, if L-1 bidder withdraws their acceptance, UCO Bank will have right to forfeit the EMD amount without making any reference.






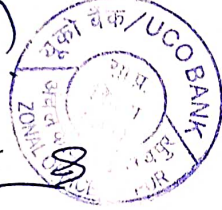

  - ❖ Do not quote rent/sale price anywhere in Part I of the form.
  - ❖ In case you desired to stipulate any term and condition, the same should be mentioned in Part I of the form.
  - ❖ Each part should be kept in a separate cover and the cover containing technical details should be marked "Envelope No. 1 - Technical Bid" and the cover containing financial details should be marked "Envelope No. 2- Financial Bid". Both these covers, duly sealed, should be put in a 3<sup>rd</sup> cover super scribed with "Offer of Premises for UCO Bank, DBU Branch at -----".
