- ATM roof to be provided by landlord within 800 to 1000 sq ft.
- The offered must have a clear title to the property.
- Premises should preferably be located on ground floor.
- The premises must be suitable from the security point of view and have all basic amenities such as adequate sanitary arrangements, water and electricity, natural light and ventilation.
- The premises structure should be strong enough to bear the weight of Strong Room, Strong Room Doors and Safe & Lockers Cabinet. **Construction for Strong Room as per Bank's specification should be done by the Landlord.**

- Ramp access should be provided by landlord for easy access to Senior Citizen and physically handicapped person.
