NOTICE INVITING EMPANELMENT OF VALUERS

Business → Empanelment of valuers) in prescribed application form along with the supportive documents. The prescribed application form is also available on Bank's website).

In addition the prospective valuers should note that:

- For the purpose of valuation under SARFAESI Act 2002, the valuers should possess registration under section 34AB of Wealth Tax Act
- For valuation of assets in respect of corporate, valuers should be registered with Insolvency and Bankruptcy Board of India (IBBI) as per extant provisions of companies Act.

Therefore the applicant valuers must submit their status in respect of the provisions under SARFAESI Act and Companies Act.

The hardcopy of application in prescribed format complete in all respect, along with all Supportive documents as stated in the application format in sealed envelope, must reach the General Manager (Credit Monitoring Department & Stressed Asset Vertical) within **10/07/2019** positively.
