Instruction to Candidates Called for Document Verification Process
Under IBPS-CRP-CLERK-XIII

The following documents in **original and self-attested photocopies** in support of the candidate's eligibility and identity are to be invariably submitted at the time of document verification. Non submission of requisite documents by the candidate at the time of document verification will debar his candidature.

- 1) Print out of Intimation letter received on e-mail for attending Document & Biometric Verification with Language Proficiency Test.
- 2) **Proof of Date of Birth** (Birth Certificate issued by the Competent Authorities or SSLC/ Std. X Certificate with DOB).
- 3) **Photo Identify Proof:** PAN Card/ Passport/ Permanent Driving License/ Voter's Card with photograph/ Bank Passbook with photograph/ Photo identity proof issued by a Gazetted Officer or People's Representative on official letterhead / Identity Card issued by a recognised college or university/ Aadhaar/ E-Aadhaar card with a photograph/ Employee ID/Bar Council Identity card with photograph.
- 4) **Three passport size photographs** that have been taken within the last three months.
- 5) **Mark-sheets & certificates** for Graduation or equivalent qualification etc. Proper document from Board / University for having declared the result on or before **21.07.2023** has to be submitted.
- 6) **Caste Certificate** issued by the competent authority in the prescribed format as stipulated by Government of India in the case of SC / ST / OBC category candidates.
- 7) **Income and Asset Certificate** issued by any one of the Authorities as notified by the Government of India in the prescribed format in the case of EWS category candidates. The EWS certificate must be valid for FY 2023-24
- 8) **Disability certificate** in the prescribed format issued by the District Medical Board in case of Persons With Benchmark Disability category.
- 9) **Ex-Servicemen candidates:**
 - (i) Candidates who are released/ retired from Armed Forces are required to submit a certificate as per Performa A (IBPS CRP-CLERK-XIII Notification). Such Ex-Servicemen candidates have to produce a copy of the discharge Certificate/ pension payment order and documentary proof of rank last/ presently held (substantive as well as acting) at the time of joining.
 - (ii) Candidates who are still in Armed Forces and desirous of applying under Ex-Servicemen category should submit Proforma B (IBPS CRP-CLERK-XIII Notification) from the Competent Authority showing his/her date of completion of specific period of engagement (SPE) along with declaration in Proforma C (IBPS CRP-CLERK-XIII Notification). Such candidates whose SPE is completed on or before 20.07.2024 are eligible to apply. Such candidates have to submit a release letter and a self-declaration that he/she is entitled to benefits admissible to Ex-Servicemen as per Govt. of India rules.
 - (iii) Those candidates who have completed their initial period of assignment and who are on extended assignment are required to submit the certificate as per Proforma D (IBPS CRP-CLERK-XIII Notification).
 - (iv) Dependents of Servicemen killed in action or those who have been severely disabled have to produce satisfactory documentary proof showing that they are Dependents of Servicemen killed in action or severely disabled and an affidavit stating that the relaxation is availed by one dependent of Ex-Servicemen or not availed by an dependent of Servicemen killed in action or severely disabled.
 - (v) In case Ex-Servicemen applies for various vacancies before joining any civil employment, should give self-declaration/ undertaking about date-wise details of application for various vacancies for which he/she had applied for before joining the initial civil employment. Further, this benefit would be available only in respect of vacancies which are filled on direct recruitment and wherever reservation is applicable to the ex-serviceman.
- 10) Candidates serving in Government / quasi govt offices/ Public Sector Undertakings (including Nationalised Banks and Financial Institutions) are required to produce a "**No Objection Certificate**" in original from their employer at the time of joining/ document verification, in the absence of which

their candidature will not be considered and travelling expenses, if any, otherwise admissible, will not be paid.

- 11) Persons eligible for age relaxation under II (5) of IBPS CRP-CLERK-XIII notification must produce the Death certificate of husband/ documents in support of Divorce or judicial separation and an affidavit/ declaration that they are not remarried.
- 12) Persons eligible for age relaxation under II (6) of IBPS CRP-CLERK-XIII notification must produce a certificate from the District Magistrate to the effect that they are eligible for relief in terms of the Rehabilitation Package for 1984 Riot Affected Persons sanctioned by the Government and communicated vide Ministry of Finance, Dept. of Financial Services communication No.F.No.9/21/2006-IR dated 27.07.2007.
- 13) Experience certificates, if any.
- 14) Persons falling in categories (ii), (iii), (iv) and (v) of Point B (I) of IBPS CRP-CLERK-XIII notification should produce a certificate of eligibility issued by the Govt. of India.
- 15) Any other relevant documents in support of eligibility

Other Instructions:

- **Candidates will not be allowed to join if he/ she fails to produce the relevant eligibility documents as mentioned above.**
- **Non production of relevant eligibility documents at the time of joining shall make the candidate/s ineligible for further process of recruitment under CRP Clerks XIII.**
- **No documents shall be directly sent to Bank by candidates.**
- In case of candidates who have changed their name, they will be allowed only if they produce original Gazette notification / their original marriage certificate / affidavit in original.
- If identity of candidate is in doubt the candidate may not be allowed to submit the documents.
- **OBC Certificate:** Must contain Non-Creamy layer clause and should be issued on or after **01.04.2023**. **Candidates belonging to OBC category but coming under creamy layer and/ or if their caste does not find place in the Central List are not entitled to OBC reservation.**
- All the educational qualifications mentioned should be from a University/ Institution/ Board recognised by Govt. of India/ approved by Govt. Regulatory Bodies and the final result should have been declared on or before **21.07.2023**.
- Proper document from Board / University for having declared the result on or before **21.07.2023** has to be submitted at the time of joining. The date of passing the eligibility examination will be the date appearing on the mark-sheet or provisional certificate issued by University/ Institute. In case the result of a particular examination is posted on the website of the University/ Institute and web based certificate is issued then proper document/certificate in original issued and signed by the appropriate authority of the University/ Institute indicating the date of passing properly mentioned thereon will be reckoned for verification and further process.
- The mere fact that the call letter(s)/ provisional allotment has been issued to the candidate does not imply that his/ her candidature has been finally cleared by the Bank. The Banks would be free to reject any application, at any stage of the process, cancel the candidature of the candidate in case it is detected at any stage that a candidate does not fulfill the eligibility norms and/or that he/she has furnished any incorrect/false information/certificate/ documents or has suppressed any material fact(s). If candidature of any candidate is rejected for any reason according to the terms and conditions of the IBPS notification, no further representation in this regard will be entertained. Such decisions shall be final and binding on the candidate. If any of these shortcomings is/are detected after appointment in the Bank, his/her services are liable to be summarily terminated.
- Any canvassing or creating influence for undue advantage shall lead to disqualification from the process.
- Any request for change of address, details mentioned in the online application form will not be entertained.
- A candidate should ensure that the signatures appended by him/her in all the places viz. in his/her call letter, attendance sheet etc. and in all correspondence with the IBPS/Bank should be identical and there should be no variation of any kind.

- Bank shall not be responsible for any application made/ wrong information provided by an unauthorized person / institution. Candidates are advised not to share/ mention their application details with/to anyone.
- The photograph and Biometrics of the candidate will be verified with the photo and Biometrics captured at the time of online tests. Decision of the Biometric data verification authority with regard to its status (matched or mismatched) shall be final and binding upon the candidate.
- Please note that a proficiency test will be conducted during the document verification process to ascertain the Proficiency in the Official Language of the state/UT (reading/ writing and speaking) for candidate has applied for. Please note that if any candidate does not possess proficiency in the Official Language of the state/UT (reading/ writing and speaking) for he/she has applied for, his/her provisional allotment made by IBPS for the post of Clerk (Customer service Associate) may be cancelled. Decision of the Bank shall be final and binding upon the candidates.
- Please note that provisional selection of candidate is subject to matching of photo, Biometrics and fulfilment of eligibility criteria stipulated for the post.
- **Further intimation/information for Document & Biometric verification along with language proficiency test will be sent by email and/ or SMS only to the email ID and mobile number registered in the online application form for CRP Clerks-XIII. No hard copy will be sent for the same.**
- **Request for change of Centre, Date & Time for submission & verification of documents will not be entertained. The candidature of candidate who do not attend the document verification process at the specified centre will be cancelled automatically.**
- Bank shall not be responsible if the information/ intimations do not reach candidates in case of change in the mobile number, email address, technical fault or otherwise, beyond the control of the Bank and candidates are advised to keep a close watch on Bank's the authorised website www.ucobank.com for latest updates.
